Rinova Ltd is a learning provider and development organisation specialised in the areas of lifelong learning (community and youth development), cultural inclusion, employability and entrepreneurship. As a social enterprise, Rinova is a member of the UK Employee Ownership Association. It is also validated by the ESFA Register of Approved Training Organisations and is listed on the UK Register of Learning Providers (reg. no. 10035859). Rinova directly employs some 30 staff and associate trainers, coaches and advisers, and co-ordinates a Consortium (see www.rinova.co.uk/rinovaconsortium) of London-based non-formal and formal learning sector organisations (Further Education Colleges, Local Authorities, NGOs and non-profit organisations, independent and private providers, enterprise agencies). Rinova's programmes have supported some 5,000 young people in the last 6 years in London, through programmes for young people such as: • Talent Match with London Youth (see next section) - a five year national programme which adopts a 'youth work' approach to promoting youth employabilty for young people aged 18-24 • Careers Clusters, two major ESFA programmes in East and South West London with some 30 schools and youth organisations - see for instance https://www.london.gov.uk/what-we-do/education-and-youth/preparing-youngpeopleworkplace/careers-clusters#acc-i-51411 • 'aspire2.be' a €2.5m pan-London preapprenticeship programme, with ten partners that delivered support to over 800 young people NEET aged 16-19 • 'Transition', a €2m programme for 600 young unemployed adults with the London Borough of Wandsworth and a network across South West London • Developing the successful pan London Business Youth Start-up Loans consortium, led by North London Community Finance Rinova is an active participant in the European dimension of its work, having participated in some 50 transnational partnerships and programmes since its formation in 2010. Since 2014 Rinova has been one of the few UK intermediary organizations for Erasmus for Young Entrepreneurs, the COSME cross-border exchange programme which gives new or aspiring entrepreneurs the chance to learn from experienced entrepreneurs running small businesses. It has also developed a number of EU programmes concerned with non-formal learning, youth and social inclusion, including: • Being the coordinator of Erasmus+ 'Heath Points' (2017) - promoting health and well-being education to young people • Coordinating 'Job Broker' 2015 Erasmus+ KA2 • Being a partner of Erasmus+ 'CREUS' supporting young people into creative and social enterprise through non-formal learning in 'non conventional' spaces • Partnering the KA3 projects 'Ep-DeM Labs' - youth participation in policy and decision-making to promote social inclusion, and 'VETIT' - developing new work-based learning for young people in ICT • Developing a curriculum in the 2015 Euro-IVET Erasmus+ KA2 project to bridge the 'culture clash' between the work culture of employers and the local cultures of urban youth and their families • Implementing the three-year 'Talent Matching' Erasmus+ project, which takes the UK Talent Match model (see below) and is developing a new mentoring framework to support young people into social enterprises and the cultural industries Rinova is particularly active in designing and validating non-formal learning strategies, supporting the development and mobility of learning and training practitioners by fostering and providing access to continuing professional development that results in both quality-driven partnerships and service provision.

What are the activities and experience of the organisation in the areas relevant for this project? What are the skills and/or expertise of key persons involved in this project?

As well as its own portfolio of work with young people, Rinova works extensively in partnership with youth support organisations across London and internationally through both its UK programmes and its portfolio of European projects. Most innovatively, Rinova is the lead partner in North London with London Youth implementing the prestigious 'Talent Match' national pilot programme funded by the Big Lottery. Talent Match targets creative support for young people who have been out of work for one year or more or who are otherwise marginalised from the labour market and mainstream society. By taking a youth-work focused approach, Talent Match is also different to typical 'youth employment' schemes, in that it is specifically focused on 'careers not jobs' and on the personal empowerment of young people rather than 'job atching'. It involves employers as well as public policy bodies and the third sector in a new form of partnership working closely with youth workers to support a strong youth voice in the design of the programme, utilising the 'Journey of Change' stepframework which maps out a set of progression pathways, and the Young Foundation's Outcomes Framework which provides a wide range of tools for measuring young people's progress in terms of social and economic independence, well-being, resilience and much more. Rinova was the management coordinator and partner in the DG Justice Judex+ project which has provided a reference point for this application. This project was aimed at improving the experience of children who were victims of sexual abuse when entering the judicial system by improving the skills of professionals communicating with them at different stages. Judex+ was led by Hope for Children (CY), joined by ZRS and Know and Can who are also partners in this application. Rinova led on the pedagogical design aspects which were brought together in a study pack as a repository at www.judexstudypack.com Its lead staff for this project are: Donna Pollard has worked with many disadvantaged groups within an inner-city environment in London and has more than 25 years experience in a variety of support contexts, in organisations such as Islington Women's Aid, as a Refuge Support Worker London (United Kingdom) and being a Senior Behaviour and Learning Support Assistant at the Camden Centre for Learning. At Rinova while implementing Talent Match, she has gained transnational experience through a digital storytelling Erasmus+ and the Judex+ project. She has specifically supported and guided women fleeing domestic violence and children living with and/or experiencing complex lives in an alternative educational setting, as well as individuals dealing with substance misuse and assisting a range of people with their next steps into employment or further education. Julie Parish has more than 30 years' experience in local economic and community education development, and has played a key role in numerous EU programmes, ncluding developing and delivering an innovative project exploring the role of Social Enterprise in economic and social regeneration. Over the last seven years at Rinova, Julie has been actively involved with EU projects concerned with guidance, culture, community development and others concerned with the validation of non-formal learning. Julie has contributed to the development of Gender Mainstreaming and Social Enterprise Toolkits and skills competencies frameworks and modules, as well as leading the youth empowerment programme for trainers in the EACEA KA3 Ep-Dem Labs (to 2018). She is professionally qualified in Marketing and Communications, Media, Organisation Development, and has worked within the field of lifelong learning, as a trainer, and developer and assessor of qualifications, for more than 20 years. Amanda Francis has some 25 years of experience of developing and managing work-based learning, employability, skills and community development support programmes thorough her work in the public, private and third sectors within the UK and across London. As the CEO, Amanda directs the Talent Match Rinova programme as well as its Careers Clusters ESFA projects, and directed Rinova's work on the Judex+ DG Justice project. She leads the staff team at Rinova and acts as the lead contact point for the partners in the Rinova Consortium.

Hope For Children" CRC Policy Center (HFC) is a non-profit international humanitarian institution that provides support services to children, young people and families in need, including social, psychological and legal support to children victims of sexual abuse, bullying, trafficking and other forms of abuse and/or exploitation. Based in Nicosia, Cyprus, our institution is guided by the standards and principles of the UN Convention on the Rights of the Child and European Union Law. HFC has approximately 50 staff members, and an independent, qualified Board of Directors responsible for its general operation, as well as an Advisory Board whose members' expertise includes areas such as Social Work, International Law, Children 's Rights & Leadership, Media & Community; Resource Management; Chartered Accountancy; Political Science & International Relations; Government Partnerships; International NGO Work & Development; Consultancy & Conflict Resolution; and Migration Studies. In addition, HFC as a pool of volunteers and an internship programme, and is a host organisation for the Erasmus+ VP (welcoming annually volunteers at the Humanitarian Division and at the Headquarters). Campaigns/projects at a grassroots level include: ONE in FIVE Campaign to stop sexual violence against children and young people; Beat Bullying Programme; human rights non formal education training to teachers and young people, operation of the European Helpline for the Support of Children and Adolescents 116111; European Hotline for Missing Children 116000. Our institution is the official partner, in Cyprus, of the Council of Europe for the ONE in FIVE Campaign; coordinates the Observatory for Returned Children; and it's a member and national focal point for the Separated Children in Europe Programme; European Network for Guardian Institutions; European Juvenile Justice Observatory; and member of the European Federation Missing Children Europe. The organisation's work has been funded by the Council of Europe; European Union; Cyprus Youth Board; Planning Bureau; United Nations; EEA Grants; and other public and private institutions. In July 2014 HFC started operating the first shelter for unaccompanied asylum-seeking minors, and in March 2016 HFC opened a second shelter. The total capacity being 42 children and young people with an option of 45 in cases of emergency. Apart from accommodation and other basic needs, the Shelters offer a number of services, including legal support, psychological support and counselling, family tracing, rehabilitation and integration services. HFC designed and delivers a training curriculum aimed at staff and unaccompanied minors in other shelters all over Cyprus. As regard the empowerment of young people, we support the educational, social and economic integration of migrant children and young people. The institution runs and manages two shelters for unaccompanied minors offering rehabilitation, integration and durable solution services, established with the approval and funding of the European Refugee Fund, and under the supervision of the Social Welfare Services of the Republic of Cyprus. Our institution participates in the international campaign to protect children on the move led by Terre des Hommes International Federation and its member organisations, which is supported by partners who join forces to develop protection mechanisms, raise awareness and advocate the campaign messages for policy change.

What are the activities and experience of the organisation in the areas relevant for this project? What are the skills and/or expertise of key persons involved in this project?

HFC has extensive experience in delivering non-formal education to children and youth, as well as to professionals who, in their work, come into contact with minors. In relation to children and youth, HFC collaborates with the Cypriot Ministry of Education & Culture to implement, upon request, workshops in school context on themes related to children's rights tackling issues such as human rights, racism, sexual abuse, bullying. Two of the most relevant programmes are the Anti-bullying, and the Convention on the Rights of the Child Campus Clubs. Both programmes using peer-to-peer learning strategies. In relation to professionals, and specifically related to the topic of sexual abuse, HFC's successful two year coordination of EU project JudEx + : Towards a child-friendly justice in cases of sexual violence against children, have brought extensive experience in training professionals working with children (nearly 400 professionals) for HFC and all the other partners. The project aimed to apply a child-friendly approach in their work with children victims of sexual violence, while setting the ground for better performing transversal multidisciplinary cooperation among professionals. In addition, HFC, in collaboration with the Government of the Republic of Cyprus, has established, and is now operating, the first Children's House in the country (based on the multidisciplinary interagency cooperation Barnahus model for cases of sexual abuse of children) in relation to which, and through the EU funded PROMISE II project, the organisation is currently supporting the training of professionals from different fields cooperating in the context of the Children's House. Further nonformal training for adults (families and professionals) is developed and delivered by HFC in the context of the Reception Centers for Unaccompanied Minors and Foster Care Programme managed by HFC (both programmes under the umbrella of the Min of Labour and Social Welfare). HFC designed and delivers a training curriculum aimed at staff and unaccompanied minors in other shelters all over Cyprus. A similar training programme was delivered to the shelter staff of Hliaktida AMKE, an NGO working in Lesvos (Greece), which runs 9 housing units/shelters for unaccompanied minors and families seeking asylum. The staff members involved in the abovementioned projects and activities are trained in their respective fields (social work, psychology, law, education) and have, in the course of working with HFC, enhanced their skills and knowledge through on-going-training and capacity building activities. Each staff member has outstanding experience in dealing with vulnerable groups, identifying needs and vulnerabilities and handling each case with the required professionalism in a manner that will best suit the best interest of the child. The main staff members implementing Keep Me Safe will be: Sofia Leitão, the Director of the Research & Development Division at HFC. She's a sociologist and holds a PhD in Media Studies (on cultural specificity in children's TV programmes), and a MA in Journalism Studies (on News bulletins for children) from the School of Journalism, Media & Cultural Studies at Cardiff University. She is responsible for the development and implementation of EU funded projects in the organisation, such as JudEx: Towards a child-friendly justice in cases of sexual violence against children. Anca Clivet, holds a double Bachelor's Degree in International Relations and Social Work from Babes-Bolyai Univ., Romania and a Master degree in NGO Management. She is a passionate social agent for positive transformation, using photography in documentary and fine arts projects. Engaged in different projects like awareness campaigns against domestic violence, Photovoice projects for marginalized ethnic groups, empowering photography projects for victims of human trafficking, seminars on vocational counselling for high school Kenyan youth, discrimination prevention and psychological support work for Roma people, participatory projects. She has experience as a trainer for children and adults, proposal writing skills and she coordinates the Erasmus+ VP at HFC. Dialechti Chatzoudi, a Licensed School Psychologist, who holds an applied master's program in School Psychology; as the coordinator of the Psychology Department at HFC she's responsible for developing non-formal educational programmes related to children's rights, awareness-raising and prevention, and for training staff as trainers in the workshops delivered by the organization.

Founded in Berlin in 1993, the EUROCIRCLE network is a European grouping of project managers actively involved in the social sectors of education and employment. In 1995, the network became a non-profit-making organization under French law, and settled in Marseille. Eurocircle is a European NGO that develops, carries out and promotes transnational projects in the field of youth international mobility, non-formal education, intercultural dialogue, social and professional inclusion, citizenship and diversity. Our objectives: - to give to both young people of the Provence-Alpes-Côte d'Azur (PACA) region and professionals working with young people, access to European mobility and non formal education in order to facilitate their socio-professional integration. 2006-2009 Eurocircle was partner in the project "PEERTHINK - Tools and resources for an intersectional prevention of Peer violence. For teachers, trainers, educators and peers" under the DAPHNE programme. PeerThink aimed at building a ground for Violence prevention with adolescents, which reflects categories like Gender, Ethnicity, Religion, educational background and other social structures systematically. In order to perform an effective anti-Violence work, the relationships between multiple social dimensions have to be included systematically: violence prevention becomes "intersectional". This new approach was tested and evaluated during a twoyears- period project. Among the results, the Manual for peer think which contains: examples of good practices, self-learn tools, methods, guidelines and tools for analysis, implementation of intersectional mainstreaming and seminars. 2010- 2013 Eurocircle was partner of "IGIV: Implementation Guidelines for Intersectional Peer Violence Preventive Work" under Grundtvig programme. IGIV aimed at building ground for violence prevention with adolescents, systematically reflecting the interconnection of categories and other social structures. In a dynamic and diverse European society it is a challenge to work against violence and discrimination. Violence prevention methods and tools in learning processes therefore should adapt to individual needs. The intersectional approach brings new tools to understand and to overcome the mechanisms of social hierarchies and dominance cultures by providing an analytical view on interdependency of social categories. It provides analysis tools, innovative methods, video clips, checklists, didactic instruments and a concept for a pilot training course in adult education for the specific target group of trainers and social workers working with adults and young adults in the field of violence prevention. IGIV realised a needs analysis with experts working in the field of diversity, violence and youth in all participating countries. An implementation guideline for an intersectional violence preventive approach in practical educational work with adolescents will be introduced in the present handbook. Based on the results of the needs analysis, a toolbox for development of everyday work in the fields of violence prevention, educational and social work was developed. It includes practical analytic tools and diagnostic instruments. A modularised training course - including curriculum and individual module descriptions - was developed according to European Quality Standards (EQF). 2014-2016 Eurocircle was partner of the GOOD GUIDANCE STORIES+ KA2 project of Erasmus+. Keep Me Safe is a targeted strategic partnership between cooperating organisations experienced in diverse and complementary areas highly relevant to support the CoE recommendation to better equip those working with young people with knowledge and practices to protect young people from sexual abuse, while equally empowering young people to protect themselves by making them aware of the risks of sexual exploitation and sexual abuse (CoE Convention on Protection of Children against Sexual Exploitation and Sexual Abuse). The need for training of professionals working with youth is also stressed in directive 2011/92/EU of the European parliament and of the Council of 13 December 2011 on combating the sexual abuse and sexual exploitation of children and child pornography, on prevention and training for professionals. The project is aligned with the UNCRC, particularly in addressing the right of protection of young people from all forms of sexual abuse and exploitation; and the right to be involved in all matters affecting them. Related to which, Keep Me Safe adopts a model of young people's participation based on four elements: space (safe, inclusive opportunities to form and express views), voice (support and facilitate expression of such views); audience (foster opportunities for young people to be listened to); and influence (young people's capacity to act as appropriate) (Lundy, 2007). The project's intellectual outputs are envisioned as mechanisms to facilitate interventions at a local, national and European level, having at their core youth work and empowerment principles constituting a focused and well-informed innovative transnational solution to a need clearly identified by EU agencies. As such, the project addresses both specific and horizontal priorities set out in the EC 2018 annual work programme: HORIZONTAL PRIORITY: SOCIAL INCLUSION - This is addressed by Keep Me Safe through its fostering of youth agency through the development of social and civic competences, and critical thinking (Youth Peers Keep Me Safe Training Methodology in IO2); by promoting media literacy (particularly through IO3 Mobile Digital Learning APP), in tackling sexual violence and, inevitably, by promoting gender equality given that gender inequality is at the root of sexual violence (UN Beijing Declaration). SECTORAL PRIORITIES - YOUTH: - The project will also address two specific policy priorities in the field of youth, namely: 1) Promoting quality youth work by enhancing the capacity of youth workers to work with young people informing and capacitating them to counteract risks, particularly sexual abuse, by working directly with their peers. The situation in European youth work is highly variable; E.g. the Local Government Association (UK) 'Tackling the sexual exploitation of children and young people under 18' strategy and resource pack for Councils' (2014) refers to youth workers as key while noting the need for training and resources; ThinkUKnow have developed resources to support youth practitioners to recognise online abuse, while Zero Tolerance and YWCA Scotland (Under Pressure, 2012) call for training, capacity building and resources in sexual abuse for youth work as a priority. In Denmark, 'Grib Begrebet' is a new youth work resource interpreting and expressing signs of abuse, but in other partner states, addressing the issue in youth work is in its infancy. This support to youth workers will be possible through the development and implementation of IO1 Development Curriculum and IO3 Mobile Digital Learning APP. These will be informed by the experience of the EU funded project JudEx+ that produced a curriculum, a manual, and a mobile application (targeted at young children) towards child-friendly communication between professionals (trainers, teachers, police officers, social workers), families, and children in cases of sexual abuse. 2) Promoting youth empowerment through fostering youth's understanding and respect for human rights (namely the right to safety from harm, the right to participation, the right to non-discrimination stated in the UDHR and UNCRC); by fostering youth volunteerism creating opportunities through the Youth Peers programme for young people to voluntarily support their peers; by enhancing critical thinking and media literacy among youth through the use of the digital tools developed within the project; and by strengthening young people's sense of initiative, expression, participation and intervention in their social spheres of action. In this respect, Keep Me Safe is equally contributing to EU's recommendation on investing in youth [COM(2016) 940], by creating innovative opportunities to education and training, and for solidarity

Please explain the context and the objectives of your project as well as the needs and target groups to be addressed.

Why should this project be carried out transnationally?

Transnationally, the prevalence of sexual abuse towards children and young people is a significant societal challenge in Europe, identified by UN Special Protection Measures (2003) and the Council of Europe Protection Convention (2007) (EIGE.europa.eu). Lampe (2002) found overall EU prevalence rates of 6–36% in girls and 1–15% up to 15% of boys under 16 (depending on variable definitions). More recently, the Council of Europe (2014) estimates between 10% and 25% of young people experience sexual abuse stating that 'available data suggest that 1 in 5 children in Europe are victims of some form of sexual violence'. The situation is confirmed in the partner countries: UK - Radford et al (2011) reported that 16.5 % of 11-17-year-olds had experienced sexual abuse, of which 4.8% was contact sexual violence. The NSPCC (2015) national strategy call indicates that 1 in 4 children/young people (24.1%) experience sexual abuse. The University of Cyprus (2014) found that 23.7% of 2000 young females are victims of sexual harassment; Cyprus Police reported instances between 2005-2015 of 6,000 child sexual abuse cases and a new study (Karayianni et al, 2017) of 15-25 year olds confirmed that 1 in 5 children/young people in Cyprus suffer from abuse or solicitation. In Slovenia, sexual abuse among children is vastly under-researched; children and teenagers are not generally familiar with (non-physical) forms of sexual violence/abuse, equating sexual abuse with physical force (rape), and consequently not perceiving non-physical actions (stalking, on-line extortion, grooming) as such. Denmark's National Centre for Social Research report (2016) showed similar findings, illustrating cases of physical mistreatment and sexual abuse that fall within the Criminal Code. In Bulgaria, 3500 cases of sexual abuse against children/young people were reported to the Prosecutor's Office, whereas the Ministry of Education reported over 2270 cases of physical sexual abuse took place at schools (in 2017). In France, according to Humanium, 1 in 10 children are affected by abuse per year, but comparative data is complicated as there is currently no law that states a child below a certain age is considered incapable of consenting to sex: 2018 sees France's first statutory rape law for sexual acts towards those aged under 15, following widespread outrage from the Montmagmy court case (in which an 11 year old was judged to have 'consented'). The need for protection from sexual abuse is visible and in this context, the Council of Europe 'European Day on the Protection of Children against Sexual Exploitation and Sexual Abuse' calls for all those working with young people to be better equipped (2016/17). Recently awareness has grown of the potential and specific role youth work can play - through the centrality of core youth work principles such as youth empowerment, youth peer development and participation. Keep Me Safe therefore creates innovative European-wide intellectual outputs which can be mobilised and transferred on a local, national and European level. It is therefore a radical and innovative transnational solution to a critical, common European challenge faced by its young people, based upon core youth work and empowerment principles. In terms of objectives and target groups, the overall aim of Keep Me Safe is to build the capacity of its key target group - European Youth Workers working with young people aged 13 to 18 – to better support young people to identify and tackle manifestations of sexual abuse. Specific objectives are to: • Contribute to a transnational capacitation of Youth Workers (through the Keep Me Safe Youth Workers programme) on awareness raising, prevention, early detection and disclosure of sexual abuse among young people by developing, validating and promoting through training, a new transferable, European level pedagogical framework of professional development. • Directly empower young people to tackle sexual abuse and support their peers by equipping youth workers to facilitate and support young people to counteract sexual abuse through a peer-to-peer support strategy. • Contribute to the EU level transfer of knowledge and practices on youth work related to the prevention & protection from sexual abuse of through user-friendly, far-reaching, innovative digital learning resource (Keep Me Safe Digital App), simultaneously enhancing media literacy and digital skills of youth workers and youth peers. • Promote transnational debate, dialogue,

awareness raising, and exchange of good practices between youth workers, youth peers and stakeholders, on counteracting sexual abuse.

What results are expected during the project and on its completion?

The results of Keep Me Safe are aligned to The Council of Europe Convention on Protection of Children against Sexual Exploitation and Sexual Abuse (the 'Lanzarote Convention'), the Directive on combating the sexual abuse and sexual exploitation of children and child pornography, and promotes the EU Policy: from a Safer Internet to a Better Internet for Kids. Keep Me Safe is a complex and ambitious project, with 3 concrete intellectual outputs generated by partners from six countries. We have scheduled the project for 24 months to ensure that the schedule is realistic and achievable and the project can produce high quality results and IOs. These are described in detail in the IO, multiplier and support sections but in summary they are: IO1- Keep Me Safe Youth Workers Development Curriculum - defining and mapping the competencies, knowledge and skills that European youth workers require in order to acquire specialist prevention and awareness knowledge and skills in their practice, to be included in the Development Curriculum - Keep Me Safe Youth Workers: the design of new, modular-based learning materials and pedagogical content for Youth Workers in the field of addressing prevention and awareness of sexual abuse, implemented through action learning in partner countries; IO2- Keep Me Safe Youth Peers Training Programme designing and testing an empowerment framework through which young people themselves as peers are equipped to work together in a peer-to-peer learning strategy, and validating this Methodology alongside the Development Curriculum; IO3 - Keep Me Safe Mobile Digital Learning App - a mobile learning resource that can be used both by youth workers and youth peers, in which the learning and content produced by the project will be digitised and contextualised, with new and complementary learning content and navigation guidance through a new user interface, accessible and utilised in mobile (laptop, tablet, smartphone) contexts. - An active, multi-channel dissemination programme, incorporating a web-based landing page, social media, advocacy at external events and stakeholder engagement, reinforced by Multiplier events in each partner country, including a final conference hosted by Hope for Children in Cyprus. These concrete results will be developed to contribute to a wider set of outcomes which, although less quantifiable, support the over-arching legacy of this programme in terms of: - Increased awareness of the benefits and importance of health prevention for young adults and improved knowledge to make healthier choices in daily. - A definition of the skills and competencies for European youth workers in the field of preventing and raising awareness of sexual abuse against young people, which will facilitate the recognition of competences in different countries, supporting the mobility of youth workers across Europe and provide a basis for promoting lifelong learning and basis for learning outcomes against which competences can be addressed, based on the ECVET methodology. - Increased knowledge, awareness and understanding of the empowered role of young people as youth peers in the prevention of sexual abuse, building their capacity to actively raise awareness related to recognising signs of abuse and addressing abuse, offering emotional, informational, and associational support and actively including their voices and opinions in the learning design. - A strong youth-focused partnership and network specialised in the Keep Me Safe approach across 6 European countries with the experience to design, deliver and complete KA2 Strategic partnership-levels projects and the motivation to mobilise the enhanced skillsets of a European network of practitioners in the Keep Me Safe concept. - Digitised, accessible learning content and guidance, providing an adaptable and flexible resource that will support the wider uptake and sustainability of the project results.

In what way is the project innovative and/or complementary to other projects already carried out by the participating organisations?

The inspiration for Keep Me Safe arose from experience of 4 of the partners in the successful and innovative DG Justice REC project 'JudEx+ Towards a child-friendly justice in cases of sexual violence against children. This was led by the Cypriot partners, Hope for Children, and was a highly specialised and targeted project which addressed the need to improve the child's experience, when entering the judicial system in cases of sexual violence against children (NB 'children' in UN and EU definitional terms includes all those up to the age of 18, Keep Me Safe is addressed towards those aged 13-18, being the 'core' age range within any wider age ranges supported by youth workers, for which this project is suitable and targeted). Judex+ developed a unique methodology and CPD training programme to promote child-friendly communication in judicial processes throughout Europe developing the skillsets of professionals working with children affected by sexual violence. This resulted from extensive research, development and intervention, establishing how variable, but also how absent, understanding of and techniques for addressing sexual abuse against young people and supporting those that had been the victims of it amongst a wide range of professionals. EU projects addressing youth sexual abuse in the field of youth work face considerable challenges of expertise and implementation and are therefore rare, with almost a complete absence of strategies and techniques available to equip young people to empower themselves. This wider lack of contextualised and relevant training programmes and resources, particularly at the transnational level, that address the tackling of sexual abuse of youth, both for young people and the youth workers that support and develop them through a wide range of youth work contexts, provides the basis for the innovation in Keep Me Safe. Larger scale, top-down child and sexual abuse prevention policies face many challenges, while continuing to struggle to be effective. It offers a 'bottom-up' solution that is scalable, participatory, transferable and easily replicable, contributing to the innovation that will be required to address this challenge. Keep Me Safe therefore draws upon the specialist experience of Judex+ and combines it with experience from successful and diverse partner projects that have focused upon the social inclusion of young people (e.g. education, health and well-being, refugee support, addressing gender-based violence, cultural inclusion and the validation of trainers in nonformal learning) to generate its innovative approach. Keep Me Safe will also connect to one the most highly underused sources in preventing and reporting instances of youth sexual abuse. Commonly referred to as 'friend-to-friend' disclosures, according to Darkness to Light, only 38% of young victims will disclose they have been sexually abused. 40% of these disclosures will be to a peer or a close friend, rather than an adult or an authority figure. These 'friend-to-friend' incidences do not guarantee official disclosure to child protection bodies or other safeguarding bodies. This is due to a lack of awareness, knowledge and route-ways to prevention by the 'peer' who receives this disclosure. A central innovation in Keep Me Safe will empower young people with the knowledge they need to become 'Keep Me Safe Peers' to their fellow young people who experience sexual abuse. It will produce resources that provide guidance, advice and information to young peers if they become aware that a friend is experiencing sexual abuse and the optimal steps are in place to follow. Both youth workers and young peers will also learn about inter-peer abuse, which can sometimes occur as a consequence of youth sexual abuse, ensuring a Youth Peer is safeguarded against it. Through overcoming a 'taboo', Keep Me Safe will contribute to informing and changing the perspectives of youth workers, wider educationists and young people in terms of understanding, and being equipped to tackle, youth sexual abuse, developing both key social, civic and inter-communication support skills, while also increasing the specialised skills which will support they will be able to mobilise to support their young peers. The ultimate, long term vision is that partners and their networks within their countries will continue to work on this agenda, to the point where the key bodies working in EU Youth view the Keep Me Safe model as the baseline from which further innovation and interventions to tackle youth sexual abuse can be developed. This application is a resubmission from the April

2018 version that is on the reserve list with 72/100 points. Despite this high score it has been substantially enhanced by fully addressing the assessor feedback on structural considerations and through the addition of London Youth to the partnership whose unrivalled reach to youth workers and youth clubs substantially strengthens this aspect of the partnership.

How did you choose the project partners and what will they bring to the project? Does it involve organisations that have never previously been involved in a in a Strategic Partnerships project?

The specific motivation for this new project came through discussions between Judex+ partners concerning their experiences of the gaps in current provision in relation to practitioners in different contexts, in terms of in awareness and prevention of child and youth sexual abuse in Europe. Therefore, in the context of youth work, and in order to develop Keep Me Safe in a holistic way, it has been important to bring together an Erasmus+ Strategic Partnership with a unique combination of complementary perspectives. These include: As the applicant, Rinova is a leading development agency in the field of innovation and non-formal learning, extensively involved in youth-oriented provision, currently being the lead partner for the north London hub of 'Talent Match', as well as implementing ESFA NEET programmes. It presently leads the 'Health Points' health and well-being Erasmus + KA2 for young people, and was a lead partner in the recently-completed Ep-Dem Labs KA3 youth empowerment project, working in London with the Greater London Authority Youth Team, Partnership for Young London and a youth work network. It specialises in the professional development of tutors, trainers and labour market intermediaries, particularly those that support young people. London Youth (LY- legally the Federation of London Youth Clubs) has never been involved in a Strategic Partnership and joins this resubmission. It has been introduced to transnational work through local mainstreaming in Rinova Erasmus+ youth programmes (Guide+, Ep-Dem Labs). Last year LY worked with over 27,000 young people through its sports development, employability, youth action and involvement, arts and outdoor education programmes and is the pan-London programme lead for Taent Match. Hope for Children (HFC) is the official CY partner of the Council of Europe ONE in FIVE Campaign against sexual abuse if children In 2017, Cyprus inaugurated its first "Children's House" run by HFC with the Cyprus government based on the Icelandic model of child-friendly, interdisciplinary and multiagency response to child abuse and services for child victims (only the 3rd country in Europe to do so holistically). As well as coordinating Judex+, it developed a mobile application called "Kiki & the Children's House" assisting professionals to explain to young children the procedures of the Children's House. ZRS has developed a unique on-line sexual violence training module which was implemented to over 90 children aged 15 years old, as well as a train the trainer version of the module for 58 experts in the judicial field. For the Children's Voices: Exploring Interethnic Violence and Children's Rights in the School Environment, ZRS developed a series of workshops entitled 'On the wings of fairytales' focusing on sexual violence awareness for children aged under 5. ZRS has also carried out work in relation to Unaccompanied Minors and also Gender-based violence (EU project Bridges of Expertise to Fight Gender Based Violence). Know & Can, as well as JudEx+ is a key partner in COMP-PASS, creating new tools and methods to help young people to socially integrate, through a storytelling digital approach and to develop an education approach of youth awareness, building one confidence and motivational skills. Know & Can also actively develop CPD programmes for youth workers and wider educators in a range of youth-focused programmes. Eurocircle has focused on a range of youth violence and sexual abuse prevention programmes including DAPHNE PEERTHINK which developed a range of tools and resources for an intersectional prevention of peer violence and also developed teachers, trainers, educators and young peers skills. These tools reflected subjects such as Gender, Ethnicity, Religion, educational background and other social triggers. Eurocircle's Grundtvig IGIV programme further built upon violence prevention amongst young people and social/youth workers. SOSU Østjylland is the second largest social and health care college in Denmark. It delivers professional educational programmes for young learners embarking on a career in health and social care, as well as offering a range of training programmes and qualifications for childcare and youth health bodies and institutions, including schools, further and higher education institutes. It works in both formal and non-formal contexts with youth workers has its own multimedia

production unit and is one of the leading developers of interactive web based pedagogical and learning materials. Overall, therefore Keep Me Safe combines specialist, high-level expertise in youth work; in supporting and empowering disadvantaged young people; know-how and experience of addressing sexual abuse in youth; high expertise in non-formal learning design for learners and trainers.

How will the tasks and responsibilities be distributed among the partners?

In Keep Me Safe, the key tasks & responsibilities will be distributed equitably amongst partners. ensuring that all contribute to the management, delivery & financial management of the overall project, inc. IOs, dissemination, partnership meetings, multiplier events and governance while utilising specific expertise in terms of the leadership of certain functions. Keep Me Safe has a collaborative approach of working & distribution of key tasks. Following discussion on the overall project framework and the specific aims of each part of it, each IO Lead partner was responsible for the design & development of an area of expertise. Therefore each of the project IOs is coordinated and managed by an individual partner - with the collective and active input of all. In each case, IOs will be managed by a project team, with oversight, review & quality assurance. The team will include the IO lead for the initial development of the design approach and the coordination of IO communications; the project co-ordinator (Rinova) in order to ensure complementary and consistency throughout the work programme; each partner undertaking allocated work in each IO and in pilot activities and in some targeted instances a co-leader/assistant leader who provides discreet & additional support work on the IO. The IO leader will distribute tasks once the IO is implemented to the wider partnership. Each partner will contribute to each individual IO as a practice organisation & to input & implement national level dissemination, while staffing day allocations of the IOs are greater for those that are taking the leading role in design, implementation & quality assurance. All Partners will be responsible for ensuring that each IO of a high quality, thus: IO1-Keep Me Safe Youth Workers Development Curriculum (Lead Eurocircle) IO2- Keep Me Safe Youth Peers Training Programme (Lead Rinova) IO3 - Keep Me Safe Digital Learning App (Lead SOSU) For IO1 Eurocircle lead, given its experience of developing practice and design in relation to educational intermediaries in new and emerging occupational roles in European contexts; while HFC will support the Development Curriculum given its expertise in child and youth sexual abuse focused training and education programmes for youth workers, educationalist, judicial staff, amongst others. For IO2 Rinova leads, given its experience of youth empowerment approaches through the innovative KA3 Ep-Dem Labs and Talent Match, together with its experience of coordinating piloting and validation programmes for practitioners, backed up by London Youth, which while new to EU projects has an unrivalled profile in grassroots youth work. IO3 - SOSU Østjylland lead, given its specific experience of developing and hosting on line learning systems, e-learning platforms and elearning applications. In terms of transversal/cross-cutting roles, each of which has been assigned a coordinator to lead partner task groups: Project Management and Implementation - Rinova: applicant, co-ordinator & overall project management, providing wider support, guidance & technical advice on IOs as required; Quality Assurance and Evaluation - SOSU Østjylland: Quality Assurance & Evaluation lead. Expertise in occupational design in learning practitioners; transnational partnership facilitation, pedagogical development, as well as direct delivery to disadvantaged and socially excluded groups, Dissemination – Hope for Children, given its experience in the engagement of stakeholders, policymakers and decision-makers in this thematic field, will provide the partnership to promote to and influence strategic contacts; Final Conference management & hosting: Hope for Children, experienced in engaging with decision-makers and running key conferences on the subject of child sexual abuse and violence; Local testing of IOs - All Partners will work with the appropriate IO lead to implement pilot testing in their individual countries; Multiplier events - all partners will design and implement localised and targeted multiplier events to contribute to the successful dissemination and exploitation of the Keep Me Safe programme.

Please briefly describe how you will select and involve participants in the different activities of your project?

A key component of Keep Me Safe is that there is a method of empowerment: a 'power transfer' throughout each element of the programme towards youth workers and young people. This ensures that the professional 'know how' that youth workers possess in relation to young people and in-turn young people's own understanding and appreciation of themselves, their peers and ultimately their needs is mobilised into the design and delivery of the key methodological elements of Keep Me Safe (IO1/IO2) as well as the frontline digital learning platform (IO3). Furthermore, through a consultative approach in IO1, youth workers are the key influencing factor in the Keep Me Safe project. The emphasis will be on recruiting youth workers able to transfer the skill-set of Youth Peers both to young people and to fellow youth workers to ensure the highest level of Keep Me Safe distribution. In the case of youth workers, these will be a combination of partner staff that are working as youth workers or in a closely related field, including volunteers, together with youth workers drawn from the local country-based partner networks in which each of the partners participate. Some were identified through the Judex+ project has having a specific interest in this area, whereas others are part of partner professional development, provider network and action learning circles. They will typically be those with significant experience of working with young people aged 13 to 18 years old. Where possible we will also identify youth workers with experience of continuous professional development/train the trainer and internal training backgrounds as part of their wider role as youth workers. This will ensure that the youth worker participants are able to implement the Youth Peer element as well as train fellow workers. In relation to young people, each partner Keep Me Safe will engage with young people as participants, with a civic-focus/active citizen perspective and aged 13 to 18 years old. The precise age range in each partner will vary within this range, depending upon the precise context and reach of each partner. This will be discussed in detail at the kick off meeting, including consideration as to the extent to which different clusters of youth peers (i.e. those aged 13-15, and those aged 17-18) may enhance or inhibit the innovation. Both the Keep Me Safe youth workers and young people that the project will represent and work with will be invited to participate at all stages of the project, from inception and consultation, design and feedback, in terms of: 1. Information sessions about the project in the preparation stage 2. Input and engagement for IO1 to provide a robust, user experience perspective on the design and orientation 3. Input and validation during development of IO1 (youth workers) and IO2 (both youth workers and youth peers 4. Feedback on the beta version of IO3 towards the finalisation of the digital learning platform and enduser feedback In quantitative terms, the project will involve the following numbers: - At least 42 Youth Workers will participate directly in the IO programme as both co-contributors to design and beneficiaries of the pilot testing, providing a practice-based validation group - At least 72 youth peers will engage directly with the programme, again as both co-contributors to design aspects as well as piloting and validation - Over 5,000 youth workers, youth peers, service managers and youth work stakeholders will be engaged via the project dissemination channels Participants will also be proactively engaged in local multiplier dissemination events organised by the partners as well as the final project conference in Cyprus

How will you support these participants so that they will fully engage in the planned activities?

Given the subject of Keep Me Safe we anticipate 50% of the youth peer participants to have one or more of the challenges indicated above. At the national level, young disadvantaged people facing the above challenges will benefit from the intensive and on-going support that is provided by their host organisation as part of its mainstream provision. Keep Me Safe is specifically resourced to support young disadvantaged people in terms of providing additional mentoring, pastoral support and empowering youth work practice. Each youth peer participant will be supported by a youth worker participant assigned by the partner. Where there are access considerations, in terms of the participation of young people with physical or sensory disabilities, each of the partners is experienced in ensuring that participatory and learning locations are fully accessible, in the widest sense of the word. Keep Me Safe has been designed to provide the partners and the participating youth workers with an imaginative, interactive approach to engage with and empower young people in to what can be a difficult and intimidating theme, ensuring that the approach is embedded in where the young person 'is', in terms of the youth peer strategy, the use of community-based locations that are not 'tagged' with the label of 'classroom' or school, and contemporary youth patterns of engagement with social media and mobile apps.

Please describe briefly how and in which activities these persons will be involved.

Consistent with the centrality of youth empowerment in the project, the persons indicated above will be involved in the same activities as their youth peers who are not specifically facing the challenges indicated. In particular, the youth peers are central to the validation and testing in the project and their voice and experience will be highlighted throughout the dissemination strategy in terms of their participation and in the incorporation of case studies in IO6 and terms of the participating youth workers and tutors that will participate in the project, they will be provided with seconded and dedicated time from the partners and/or their employers to participate, both as co-creators in the (with due regard to issues of anonymity and confidentiality).

Preparation

Please describe what will be done in preparation by your organisation/group and by your partners/group before the actual project activities take place, e.g. administrative arrangements, communication about the activities, selection of the persons, coaches, involvement of stakeholders, etc.

If the Keep Me Safe application is approved Rinova will coordinate the implementation of a preparatory phase of work, based on successful experience from previous projects. Specifically, as project coordinator Rinova will: • Implement requirements resulting from the National Agency application assessment to establish the overall grant agreement, including the comments of the assessors. Resulting amendments or adjustments of the project will be in turn assessed and the partnership notified, and any resulting impact upon the intended project activities will be reviewed with a view to agreed actions at contracting. • Prepare the contract agreements between each project partner and Rinova. We will set up and distribute the administrative documents (in particular the partners' agreement and its annexes) and the project management guidelines, and prepare the content of the Finance and Administrative Handbook, including all templates and evidence requirements to be used on the project. • Detail a clear project framework including the timelines and project processes. Rinova will also set up a Dropbox repository on its company business account and provide access to all project-nominated partner staff with references and editorial rights so that they can review and comment upon initial project documentation. • Set up the kick-off meeting with a suitable date for all partners, set the agenda and prepare all necessary logistics. In addition, the partners will conduct a preliminary, introductory Skype meeting prior to the transnational kick-off meeting between the lead contacts, in order to share general ideas, expectations, and concerns about the project. In order to prepare for the kick off, the relevant partners will be asked to prepare: a Quality Assurance Plan to document the QA and evaluation strategy (SoSu) - a Dissemination Plan to document the dissemination strategy (Hope for Children) - confirmation of contact points and delivery team (all partners); this will also include confirmation of relevant registrations; all Rinova staff are enhanced DBS-checked and partners will confirm the status of their equivalents - a Visual Identity 'story board' (Rinova) Initial orientation As the project builds upon and develops the experience of the DG Justice Judex+ project, each partner was fully consulted about the plans for this application. There will however be a further orientation phase as the partners (Rinova, Hope for Children, Know and Can, ZRS) and key staff who were involved in the original Judex+ project will induct further Eurocircle, SoSu and London Youth as partners, and all staff across the partnership that were not involved before, while also giving consideration to any early or induction implications for all project staff, given the very different focus and target group of Keep Me Safe. If the application is approved, a press release will be prepared by Rinova and circulated to all partners for adaptation and use. This will announce the approval, the support from Erasmus+ and summarise the project's aims, objectives, its partners, and its aspirations. The partners will also be asked to begin the notification of the project approval of their key stakeholders in each country.

Please provide detailed information about the project activities that you will carry out with the support of the grant requested under the item 'Project Management and Implementation'

As coordinator and applicant, Rinova will both devise and maintain a range of measures and activities to underpin the robust, timely and participative management of the project. On the safeguarding side, this will include specific attention to the thorough preparation and monitoring of those participating in the project (see relevant sections in this application). In addition Rinova will set up and manage the internal reporting system: standardised formats and procedures for internal reporting of progress and expenditure; act as the initial point of contact for information, and first level queries for contracting; draft of content for finance and administrative handbook, partner guidance, reporting templates; first level checks for partner submission of information relating to monitoring and contract compliance - both partners and also compiling of internal records; checking of claims and referral of errors/queries; maintenance of euro account and processing of bank transfers to partners; managing routine gueries from partners in relation to compliance, project work plan (ie deadlines, contents); drafting of financial reports for monitoring and review and interim (and in due course) final reports, including first level checks of partner submissions (financial and record-keeping). How will you ensure proper budget control and time management in your project?

The project work plan, summarised on the project Gantt, has been carefully designed to provide an appropriate balance between the requirements for proper and efficient project management and quality assurance; development, testing and implementation actions; as well as dissemination and potential exploitation opportunities. To manage and implement the project, we have scheduled the project for 24 months and budgeted it towards the maximum allowable, in order to ensure that the schedule is realistic and achievable and the project can produce high quality deliverables with the sustainable results that are envisaged. Milestones and deliverables are clearly identified within the work plan. To ensure efficient, balanced and transparent budget and time management, the coordinator will produce a Project Handbook, which will include project management guidelines. Its components will support the various management tasks needed to properly implement and monitor the project to success. For day to day development of the project a continuous time and budget system among the partners as set out in the Finance and Administrative sections of the Project Handbook will be supported via virtual communication between partner meetings. These will be organised at project milestones and will monitor the project processes, achievements and shortcomings and plan subsequent tasks and events. Our budgetary strategy is to allocate resources and costs in a proportionate way, in that personnel effort is assigned across the partnership based upon an equitable and balanced approach to the distribution of staff days, balanced by resources targeted at partner specialisms and responsibilities. Each of the intellectual outputs sees the partners contributing in a balanced way, with allocations increased for those that are leading IOs or that have a particular additional role within. We have not sought to justify any Manager or Administrative staff days for Keep Me Safe. We have allocated the budget to internalise the development of know-how and capacity-building to ensure excellent value for money and cost-effectiveness. The partners are utilising their own time and expertise and language skills in the partnership for operational translations and interpreters. Financial Management will be managed and monitored by Rinova and clear procedures will be communicated to all partners through the Finance and Administrative Handbook. The financial monitoring of Keep Me Safe will also ensure that the resources allocated to partners were used in appropriate ways; that all budget expenses are clearly evidenced and documented; that all budget expenses follow the relevant Erasmus+ KA2 regulations and that partners have used the resource management tools supplied for financial management in the project in an appropriate and timely fashion. Each partner will receive relevant instalments of grant (including pre-finance) upon proof of eligibility and arrangements, and also the conducting and delivering the agreed load of work and services. All partners will report to Rinova on their expenses and their financial management of the project. In this way Rinova will secure that the budget spent will reflect the actual work done by all members of the consortium, and will also provide a 'Financial Help Desk' at all face-to-face partner meetings where partners can clarify any issues arising. Resource utilisation quality will be monitored periodically in quarterly monitoring reports that relate to how the monetary and non-monetary contributions, assets, and resources that are made available to the project. This has proved to be a valuable instrument in previous KA2 projects, which allows control of spent budget and need for possible corrections. Keep Me Safe has been planned to ensure that there is a consistency between the work programme and the budget; all aspects of the budget are clearly related to justified activities in the work programme. The budget provides for adequate resources necessary for success, it has been arrived at through detailed calculations on an excel worksheet, which can be supplied to show how stages and steps within IOs have been calculated per partner, and is therefore neither overestimated nor underestimated. We have worked hard in our planning to ensure an overall an efficient and effective use of resources to implement the project and value for money.

How will the progress, quality and achievement of project activities be monitored? Please describe the qualitative and quantitative indicators you will use. Please give information about the involved staff, as well as the timing and frequency of the monitoring activities.

The Project Manager, IO leaders (assigned according to partner expertise in the thematic areas of the project), and national managers will ensure the implementation of activities according to the structure and timeline proposed and clearly stated in the Project Handbook. The quality assurance cycle will be guided by a Logic Chain at four levels: input (timely and proper execution of activities), output (review of the delivery of direct results), outcome (the peer review and assessment of quality assurance) and impact (specific and sustainable changes resulted from the outcomes). The process will be formative enabling project learning, adaptation (including corrective measures) and planning. Rinova has extensively designed and implemented working instructions and procedures for management, quality assurance and monitoring that have underpinned the effective performance of a number of EU projects, drawn from ISO9001 compliant practice. Alongside the communication, project management and budgetary control mechanisms described earlier, the project manager at Rinova, Amanda Francis, is responsible for monitoring progress on a quarterly basis through online communication with partners, and will activate the partnership peer review and reporting system for written monitoring at its 6-month intervals. Bilateral feedback to partners that requires remedial or urgent action will be sensitively handled, initially on an individual review basis, accompanied with collective statements of progress and Quality reports that will be submitted to each transnational project meeting to update on performance: degree of compliance of procedures, objectives and results. These reports will also contribute to contents of the NA Progress, Interim and Final Reports. This will be summarised in the Quality Assurance Plan, which will also set out set out quality assurance and evaluation methods, scope, Key Performance Indicators (KPIs), deliverables and milestones, in which the Risk Analysis mechanisms and tools to support the risk management arrangements described elsewhere will be included. This will be overseen by Bodil Mygind Madsen at SoSu Østjylland who has over 25 years of experience working in international projects in the field of formal and informal education and learning, specifically in projects concerned with vulnerable and disadvantaged young people. Bodil will be internally responsible, in close cooperation with Rinova, for the coordination of assessment of quality assurance and evaluation. Detailed Quality assurance indicators will be evaluated according to Key Performance indicators (KPIs), which will provide the standards and guidance the on-going peer review of quality assurance complemented by a summative assessment at the end of the project. The quality and monitoring will be assessed also according to the project's schedule (key reporting dates, milestone and partner meetings). Monitoring will support the project quality assurance and will include the following monitoring and assurance indicators that will form the basis of more detailed KPIs, as well as providing thematic areas for monitoring and quality reports: 1. The Keep Me Safe timeline is respected 2. Progress reporting, financial and expenditure claims and contract compliance requests are submitted in a timely fashion and supporting evidence is compliant 3. The definitions and understandings of manifestations of sexual abuse towards young people are applied consistently and appropriately in the way that they inform all project activities and results 4. Equal opportunities are ensured at all levels and throughout the project activities, with particular emphasis placed on gender equality and gender-based considerations, race equality, cultural considerations and accessibility in its fullest sense 5. All quantitative undertakings (participants, stakeholders, learners, attendances at multiplier events and joint staff training events) are secured 6. Numbers of youth workers (min. 45) and youth peers (min.72) participating in the design, pilot testing and validation activities 7. All qualitative and monitoring milestones are complied with 8. Dissemination activities are fully implemented, quantitative targets achieved (min. 5,000 stakeholders engaged) 9. Key audiences are identified, engaged and fully informed 10. Participants' satisfaction levels are monitored in terms of the project activities Quality assurance will support the operation of the project to: achieve greater consistency in

How will you evaluate to which extent the project reached its results and objectives? What indicators will you use to measure the quality of the project's results?

Evaluation in the project will be an on-going, underpinned by a commitment to seek feedback and produce analysis and solutions, in a transparent manner. The process includes formative evaluation in terms of procedural aspects and activities of the project (efficiency, cooperation, validation) and substantive aspects (outputs, results). The Quality Assurance Plan will set out the method for ensuring a constant reflection and assessment being founded on how specifically the defined objectives will be evaluated, particularly in qualitative terms in relation to the achievements of the project against its stated objectives and planned results. The achievement indicators will be designed as 'statements' with regards to project objectives and results. This practice and procedure will influence the qualitative development of the project's primary activities and shapes the contextualised Quality indicators. Accordingly, the qualitative and quantitative evaluation methods (partner satisfaction questionnaires, interim and final evaluations, interviews, observations, event/workshops, quality reports, etc.) will cover mainly assessment and achievement requests, (details of specific areas of work as well as a broader overview of project) at different stages of project's implementation. The formal internal evaluation reports, produced at six monthly intervals will use a 'traffic light' system (green = fully achieved; amber = partially achieved, with some shortfall(s) requiring moderate action; red = not achieved, required urgent/remedial attention) to assess the extent to a objective has been met. The partnership management meetings every 6 months will operate as an overall peer review and evaluation group and will be jointly responsible for validating and certificating the timing and quality of the projects results and Intellectual Outputs. Effectively using the evaluation findings for future phases will assure the consistency and quality of the project deliverables. The quality evaluation will focus also on the project's impact and its evidence of impact at multiple levels, from local to EU levels. All partnership meetings' agenda will take in evaluation as an intrinsic process for collaborative review of progress and achievement. Additionally, dissemination and impact will be shared including identifying challenges and solutions. This process will be facilitated by SoSu, working closely with Rinova, to ensure that there is a continuous quality feedback loop of 'plan, implement, review, improve' throughout the project. Keep Me Safe has planned several actions to ensure that the project is evaluated throughout: (i)Project meetings will be the subject of specific internal evaluation exercises, evaluated by all participants and coordinated by SoSu Østjylland. (ii) An Interim Peer Evaluation Report (with interim questionnaire), produced by SoSu Østjylland. (iii) Each pilot testing and validation programme for the development curriculum and youth peer methodology application in each country will be evaluated by the partners at national level, coordinated through common approaches designed jointly by SoSu Østjylland and Rinova. Qualitative indicators will measure satisfaction level of participants, stakeholder viewpoints, level of enhanced knowledge based on evaluation questionnaires, comments/feedback. A 'zero measurement / baseline' approach will be used, in which an ex ante exercise will be completed by participants prior to the pilot programmes, and a post ex assessment undertaken, in order to identify and quantify specific aspects of impact. The comparative findings from prior to post training implementation will reflect the newly acquired knowledge and abilities (qualitative indicators) of detecting signs of abuse, communicating with a potential victim and supporting reporting to the assigned entrusted national protective agencies for further analysis and therapy (e.g. the model applied by Child's House). The indicators to be used in terms of the achievement of project results, formatively and summatively, will be elaborated further in the Quality Assurance Plan, but in short are summarised as the extent to which: - Keep Me Safe has achieved its objectives, quantitatively and qualitatively - The pedagogical training programmes incorporate and introduce to young different methods/areas of knowledge - Partners are equipped with strategies and plans to effectively implement the Keep Me Safe methodology and training curriculum that they have co-created - The participants (youth workers, young people) in Keep Me Safe reflect the diversity of their communities

What are your plans for handling risks which could happen during the project (e.g. delays, budget, conflicts, etc.)?

Keep Me Safe is a complex project in a field which requires careful attention to safeguarding, wellbeing and professional integrity. There is a significant amount of innovation, which in itself generates a range of factors to consider which may impact on delivery. Therefore a detailed and robust approach to risk management is necessary to consider in advance the factors that can impact negatively and to consider appropriate contingencies. Built into the quality plan will be a specific Risk Register. In terms of mitigating the risks presented by budget, delay or conflict, the risk register will record and analyse the following risk factors: 1) Conflicts between partners (low risk/high impact)e.g. poor quality deliverables being presented: The partner contracts will contain a specific conflict resolution procedure, in the form of 'steps' to be followed prior to any legal recourse. This will complement our project management, regular monitoring and checks on progress and our ongoing evaluation will provide us with an early alert system. We will encourage a supportive project working environment and collaborative working to indicate at an early stage any potential issues so that other partners are able to help and support where appropriate. 2) Budget changes/issues (moderate risk/moderate impact): The budget is realistic, manageable and underpinned by sound financial management principles from previous experience. With the exception of London Youth, all partners have experience of delivering Erasmus+ programmes and so understand the principles of how expenditure is controlled in KA2 and reported in the programme, so we do not expect significant alterations in the budget. Rinova will induct London Youth in the specifics of KA2 finance operatives and monitor the financial progress on a quarterly basis and if so will raise the issue with the partner/s concerned and propose a budget change to our National Agency. 3) Slippage in the project timeline (moderate risk/high impact): We will mitigate this by having a specified project schedule, based on realistic and practical timelines, detailing the delivery, completion and reporting points throughout the project, incorporating regular monitoring and checks on progress, quickly identifying any potential delays and responsively taking action. 4) Loss of partners (low risk/high impact) or key staff (high risk/moderate impact): We have mitigated this by choosing partner organisations that have are familiar with the range of demands that these projects present. However, we have a network of other organisations with commensurate stature who can bring expertise in youth work and in specific safeguarding and well-being education if necessary. Partners are of a sufficient capacity to be able to withstand and replace the loss of any nominated staff and the work programme is shared across staff teams so that if there are staff changes the project expertise is not lost. 5) The Intellectual Outputs and activities require revision (low risk/moderate impact): We have designed the project after careful consultation with partners who either worked together in the DG Justice Judex+ predecessor or with whom we have worked with on youth-oriented projects. In any project which explores new areas and develops innovative solutions the requirement to specify results at the outset can present some challenges. Therefore we have produced results and activities which, although detailed, contain sufficient flexibilities. 6) Lack of interest from Youth workers (low risk/high impact): Keep Me Safe provides added knowledge and skills to youth workers to address a phenomenon that, very often, silently affects the young people they work with. The addition of London Youth to this resubmission brings robust perspectives from youth workers and will advise the partnership on targeted measures to activate networks of youth work and dissemination from its onset to ensure the target group engagement. 7) Limited participation of youth (moderate risk/high impact): Keep Me Safe partners have an exceptional record of working with young people. Issues of safeguarding and consent will be addressed at national level to ensure the safe, consented participation of youth peers. London Youth and HFC in particular, whose daily work is oriented solely towards children and young people, will jointly monitor partners' effectiveness and outreach strategies to swiftly address any emerging difficulties.

Please explain how the results will be achieved.

Keep Me Safe is an ambitious and complex project, with a number of high-level processes and three concrete intellectual outputs generated by close cooperation and integrated working between diverse partners from six countries. Furthermore, Keep Me Safe necessitates partners to work together in a way that combines their expertise in diverse fields - expert knowledge and experience in tackling sexual abuse towards young people (with Hope for Children as practice lead), extensive experience of working with young people, particularly in a youth work context; pedagogical and didactic experience in developing work-based and non-formal approaches to the continuous professional development of professionals, including youth workers; writing learning materials and facilitating action learning contexts; and technical design competency in relation to e-learning and the production of mobile apps. Whilst the partnership has been specifically constructed to provide all and each of these capacities and perspectives in the consortium, together with a high degree of experience of collaborative working in a transnational context, successful implementation of the project will require high-level commitment and input from senior an experienced personnel throughout. As a result, we have scheduled the project for 2 years/24 months to ensure that the schedule is realistic and achievable and the project can produce high quality deliverables with the sustainable impacts envisaged.

Our approach to ensuring that the results will be achieved includes a carefully integrated and phased approach to the work, in which the key milestones and timelines are summarised in the project GANTT chart, and include:

- * Establishing a clear project logic chain, which will be described diagrammatically and in narrative terms in the Quality Plan;
- * Robust project management, monitoring and contract compliance processes, complemented with a supportive and highly facilitative approach to partnership working;
- * Building stakeholder networks with relevant organisations at the local, national and transnational level working with young people;
- * Iterative development practitioners will implement in practice IOs within pilot activities to ensure the continuous adaptation of the IOs to local contexts and creation of the ownership by contributing to the development;
- * Placing user validation and user input at the heart of project design, with a focus on needs and sustainability of results;
- * Combining skills and know-how across the partnership, supported by transnational partners who have developed successful methods to ensure cohesion and comparability in joint development projects;
- * Development of practices through genuine transnational cooperation and 'bottom up' findings to ensure that the results are informed both by established and evidenced good practice, and also to the identified needs of the target group of youth workers and the challenges faced by young people in this issue;
- * Training of national facilitators in a transnational context;
- * Use of quantitative and qualitative data in informing the design of results;
- * Continuous quality assurance and evaluation of the project activities and deliverables, communication and project management within the partnership;
- * The use of impact assessment through zero and baseline measurement techniques and follow-up measurement of outcomes;
- * Continuous and ongoing dissemination, through a targeted, multichannel approach, that recognises that messages and material for dissemination on the topic of tackling sexual abuse towards young people requires careful thought, sensitivities, gender and cultural perspectives;

We have allocated roles and resources across the partners in a way where there is expertise, so that the most productive partner is undertaking or leading work - with both economy and time efficiency in

mind. We have balanced this consideration with a commitment to allocate resources and costs in a proportionate way, in that personnel effort is assigned across the partnership based upon an equitable and balanced approach to the distribution of staff days, balanced by resources targeted at partner specialisms and responsibilities. This aims to show an equitable approach to work allocation – ensuring that staff allocations and budgets assigned to partners are commensurate with the actual level of their input. Otherwise we have allocated the budget to internalise the development of knowhow and capacity-building to ensure excellent value for money and cost-effectiveness.

How will you communicate and cooperate with your partners?

Each of the partners has considerable experience with transnational project working, but it will be important at an early stage to ensure that nothing is assumed or taken for granted. Therefore, the terms of collaboration of the project will be compiled in the code of conduct that are appended to the partner agreement, which will be drafted by Rinova, discussed among the partners and agreed upon at the kick-off meeting. This will extend beyond the mechanics of communication and cooperation, for instance dealing with questions of inclusion, respect and diversity as well as seeking an undertaking that partners will, at all times, cooperate in a constructive way that respects each partners' cultural context, complementary expertise and methods of work. No matter how experienced the partners are or how familiar many of them are with each other, there is always something to learn and not every delegate from the partners will be experienced with transnational projects.

As noted above in project management, effective communication will be ensured by regular formal reporting points and informal working practices, such as the use of open source and free to use Skype for bilateral and multilateral virtual cooperation and review between formal transnational meetings as well as email and where appropriate telephone calls. Each of the partners is proficient in English, the working language of the project and it will be necessary that any participants in the transnational project meetings will be able to use English to a level where they can participate meaningfully.

The project Gantt sets out a clear transnational meeting schedule which is to be followed and all partners are required to attend. Prior notification will be sent out in good time to all partners and meetings agendas will be circulated as drafts for comments. During the project lifetime six transnational meetings will be carried out. In the case when a project partner is not able to be present at the meeting, an arrangement will be made in order to virtually have the presence of the partner and to have full participation.

Regarding decision-making, all major decisions will be taken, whenever possible by consensus and consensus-making will be a specific objective of the way that Rinova chairs and facilitates the meetings. Outside of meetings, the decision-making process will be set out in the partnership agreement, including escalation procedures (see handling of conflicts). Furthermore, online meetings in sub-groups will be planned to intensify transnational cooperation in the activities. To ensure the cooperation between partners during the whole life cycle of the project, virtual communication will be intensively used. All project partners will have full access to the critical project information. All important documents - the grant agreement with the NA, this application, all financial annexes, reporting templates, as well as the pro-formas and draft documents for emerging results will be circulated among partners and stored in the project workspace on Dropbox, available to all partners all the time. Responsibilities for completion of the project aims are equally shared among partners. Each partner is responsible for fulfilling the respective tasks in the required period.

The Keep Me Safe Youth Workers IO consists of 3 strands:

- Youth Worker Role Specification
- Competency Framework (sexual abuse prevention and awareness specialist) Youth Worker
- The overall Development Curriculum

The aims of the IO are to:

- 1. define, specify and map the scope and range of role responsibilities and activities (including counselling, mentoring, group work, training, awareness raising, confidentiality management, referral, reporting, dealing with statutory authorities, families and communities) competencies, knowledge and skills that European youth workers require to acquire specialist prevention and awareness knowledge and skills in their practice 2. produce a comprehensive Competency Framework for European youth workers in the field of preventing and raising awareness of sexual abuse against young people, which will facilitate the transfer and recognition of competences in different countries, supporting the mobility of youth workers across Europe and provide a basis for promoting lifelong learning and basis for learning outcomes against which competences can be addressed, based on the ECVET methodology. It will produce a comprehensive matrix of what is required in terms of Knowledge, Skills, Behaviour and Competences to create a friend-to-friend role able to prevent sexual abuse amongst young people and ensure disclosure towards peer to peer approach. The Framework, provisionally estimated to operate at EQF Lvl 5 for youth workers will provide a basis from which youth workers and wider educationalist working with youth to determine the best approach for the delivery of a Youth-led peer system.
- 3. develop a modular-based learning programme, a Development Curriculum, consisting of newly designed materials and pedagogical content for Youth Workers in the field of addressing prevention and awareness of sexual abuse, implemented through action learning in partner countries. The Development Curriculum for Youth Workers is at the heart of the Keep Me Safe programme, in that it:
- Designs its learning programme to develop the capability of the Keep Me Safe youth worker in the field of awareness and prevention of sexual abuse of young people
- Constructs this learning programme, in the form of a modular, learning outcomes-based approach implemented through facilitated action learning sets and supported by learning materials

• Validates this learning programme in a non-formal context, through an extensive pilot testing programme in each of the partner countries

Provision of services requires an in-depth knowledge of youth sexual abuse, safeguarding and legal procedures of the host countries, but also a proper understanding of the needs of the young people, their families and, often, the perpetrators. However, disclosure of instances of child abuse still remain an issue in all partners' countries, including the UK, with 1 out of 5 children throughout Europe still experiencing child abuse (Council of Europe, 2014) and in the UK, for instance, only 38% of young victims disclose that they have been abused (Darkness to Light). The Keep Me Safe youth worker role requires pedagogical knowledge and skills sufficient to provide understanding of the many facets of young people confronted with this experience, or finding themselves vulnerable to it, for example, developmental psychology, cognitive psychology, behavioural psychology, and sexual abuse understanding.

Alongside this is the engineering of instructions: how to plan and deliver content to groups of young people who enter the learning environment each day or each period, estimating young people's level of understanding and taking an approach to learning that will stimulate curiosity and engagement in a challenging field.

The design and development of this IO has a number of innovatory elements. First, it develops new content in the field of tackling sexual abuse against young people, with specific reference to embedding this content in youth work practice. This content will be developed at the transnational level in order to maximise its transfer potential. Second, the use of facilitated action learning provides a non-formal approach that is not dependent upon the formal qualification or certification systems or structures at a national level. Whilst this can present challenges in terms of recognition, it does provide a flexible and adaptable approach that is relevant, contemporary and highly transferable.

By defining the scope of role and activity responsibilities in this field for youth workers at the EU level, and by constructing a Competency Framework underpinned by ECVET design principles and aligned to the EQF, this IO will generate innovation for youth workers in terms of defining roles and responsibilities related to working with young people on the issue of awareness and prevention; whilst also benefitting from the acquisition and recognition of highly transferable competencies, all designed at the EU level to foster mobility.

Please describe the division of work, the tasks leading to the production of the intellectual output and the applied methodology

This IO will be led by Eurocircle, which has a wide range of experience of developing professional and specification roles for intermediaries working with disadvantaged and diverse youth. Under its specification and coordination, each partner will undertake the development and design, including best principles in end user engagement and consultation in their own country contexts. In order to maximise the learning from Judex+ in the input at this originating point, Hope for Children and Rinova will work closely with Eurocircle bringing its expert practitioner/training provider perspective into the academic rigour.

Task 1- Specification

Eurocircle will draw together a design specification for the preparation and conduct of IO1, in the form of a written specification of the areas to be addressed. Drawing upon the initial needs analysis and rationale that is presented across this application it will define the specification for the work to be undertaken, drawing from expert and high-level content

Task 2- Guidance and reporting requirements

To ensure that the consultative and investigative development work is undertaken in a coherent and consistent way, the specification will be complemented with written Reporting Guidelines aligned to the Profile and Curriculum Development requirements. This will set out methodologies combining quantitative and qualitative types of inquiry:

- *Interviews with stakeholders and expert sources
- *Focus groups with youth workers

Task 3- Investigation and elaboration

This will be country specific and each partner will be responsible for their field work. Examples of how Friend-to-friend/youth peer approach may currently be manifesting itself in a formative or formal way will be particularly sought as will decision-makers and practitioners responsible for child protection and sexual abuse disclosure practices

Task 4- Assembly and elaboration

Each partner will assemble their contents according to the common template provided by Eurocircle for mapping findings and drawing out conclusions. Eurocircle will ensure that the results are comparable and relevant to the set of criteria decided prior to the fieldwork, and draft a summary that will inform the Keep Me Safe Youth Workers Development Curriculum

Task 5- Specification of role responsibilities and activities

Eurocircle will finalise the Role Specification to inform and be included in the final Keep Me Safe Development Curriculum. This will provide an understanding of the needs of the target groups and the ways in which to implement Role Specification that will support and sustain the Keep Me Safe Youth methodologies in partner countries

Task 6- Specification of common ECVET competences matrix template

- designed by Eurocircle, aligned to ECVET principles, to provide a structure for each of the partners defined by the Role Specification. Partners will each be assigned relevant areas to detail the competences in terms of (a) Knowledge: the acquisition and absorption of information and data (b) Skills: application of the information and data (c) Competences: the ability of the Youth Workers to transfer knowledge and skills to varying and different contexts in relation to preventing and identifying sexual abuse against young people

Output Description (including: elements of innovation, expected impact and transferability potential)

A methodological concept, empowerment framework and training programme, through which youth workers are equipped to facilitate and support young people themselves to form peer support and learning groups, working together through a peer-to-peer support strategy.

The Youth Peers Keep Me Safe Training Methodology is central the Keep Me Safe programme in that it:

- Designs the learning programme to develop the capability of the Keep Me Safe Youth Peers to deliver first Youth Peer development programmes preparing young people to be active peers in situations of prevention, awareness and support in relation to sexual abuse
- Constructs this learning programme aligned to a defined Youth Peer Volunteer role specification for the Keep Me Safe youth worker
- Validates the Keep Me Safe youth worker and peer learning programmes through an extensive pilot testing programme in each of the partner countries

It is complementary to IO1, but is distinct from it; whereas IO1 is concerned with equipping youth workers with specific content, resources and methods to build their professional capacity to address issues of awareness raising and prevention of sexual abuse in those young people that they support, IO2 is concerned with the development of an innovative empowerment methodology to facilitate and support the formation and operation of youth peers as independent, mutually supportive and reinforcing mechanisms. This is in recognition of what is commonly referred to as 'friend-to-friend' disclosures; according to Darkness to Light only 38% of young victims will disclose they have been sexually abused. 40% of these disclosures will be to a peer or a close friend, rather than an adult or an authority figure. Such 'friend-to-friend' incidences to not guarantee official disclosure to child protection bodies or other safeguarding bodies" hence the need for a methodology and training - highly transferable across European contexts to recognize, support for safe disclosure and reporting, given the incidences of a young person talking to a friend and not an authority figure. It also recognises that, particularly following the impact of public sector austerity in recent years on publicly funded provision such as youth work, youth workers can only spend a limited time on such specificity with young people, whereas peers can spend time together at school, youth clubs, leisure time and other contexts, so the opportunity for disclosure and support is greater.

In all European countries there are child protection agencies, with various degrees of success and experience. However, resulting from the absence of supported 'friend-to-friend' approaches, youth sexual abuse prevention can face limitations, especially in relation to disclosure on a safeguarding

procedural framework. If a disclosure is not reported within the rule of the local child protection service, then the investigation and potentially taking a perpetrator through the legal system is severely impaired. The current systems (at national, local and indeed at an EU and international level too) are primarily driven by adult and civic authorities working in child abuse prevention. This reflects and is in part determined by the institutional structure with the lead at national government level (in the UK coming from the Department for Education, albeit linked to the Home Office, Departments of Health and Social Care, Communities and Local Government) and at local government level usually provided by child protection authorities in local authorities. There is limited evidence of youth peer approaches within current legal child protection services. The JudEx+ partnership brought a unique method to developing a child-friendly judicial system for children affected by sexual violence. However, JudEx+ and similar programmes have focused exclusively on professionals working with children and young people who have taken the step to disclose their experience; the vast majority of sexual abuse against young people does not get disclosed or when it does, cannot be taken forward by child protection services because safeguarding procedures, specifically reporting have not been adhered resulting in the child protection agencies being unable to investigate fully and take perpetrators to court.

Please describe the division of work, the tasks leading to the production of the intellectual output and the applied methodology

The leader of this IO will be Rinova, to take advantage of its experience in implemention, on the ground youth empowerment and accompanying approaches in the Talent Match and Ep-Dem programmes, comprising innovative ways of transferring learning to youth, together with the insight gained via their involvement in JudEx+ together with its experience of coordinating piloting and validation programmes for youth support practitioners. All partners will participate in development of this IO in order to ensure its relevance to the local needs.

Task 1 Specification of the Keep Me Safe youth peer learning strategy

The methodological development recognises that Keep Me Safe cannot in the short term create young expert peers in the addressing sexual violence in young people. A learning strategy will be produced, in the form of a specification, to outline the approach through which the Youth Peers will be equipped with knowledge, training, guidance and a framework for personal improvement, supported by guidance and facilitation techniques from the youth worker, constructing the key modular domains for this strategy, using non-formal and informal learning methods suitable for young people and a framework for content development.

Task 2 designing the Youth Peer facilitation training and support programme

The Keep Me Safe youth peer role requires pedagogical knowledge and skills taught at a youth-level which will provide sufficient understanding of what sexual abuse is, how to support fellow young people, how to support yourself and how to ensure disclosure appropriately in terms of specifying the learning content to address the youth peer facilitation KSCs in IO1. Although it is difficult to be prescriptive in terms of the precise methodological approach at this juncture, this will be designed to ensure each Keep Me Safe youth peer is able to develop through the support of youth workers the necessary skills to be a Youth Peer and participate in a youth peer network structure. It is envisaged that the training approach will include:

- Understanding & Discussing Sexual Abuse

- Safe behaviours & inter-peer conduct
- Youth peer networks: Purpose, benefits, sustainability & independence
- Youth Peers counteracting sexual abuse: Awareness Raising & Prevention
- Peer-to-peer support
- Youth support supporting youth peers in sexual abuse disclosure situations

Task 3 Testing and validation

All of the design and development work to this point is intended to produce an integrated curriculum and learning programme. Therefore, in order to robustly determine the valid outcomes, the designed modular learning programme will be tested with at least 42 Youth Workers youth workers and at least 72 youth peers across the partner countries via an action learning-based pilot testing programme of the youth peer training methodology. This will also incorporate and integrate a commensurate and comprehensive pilot test and validation of the ex ante Development Curriculum outcome of the modular-based learning programme, consisting of newly designed materials and pedagogical content for Youth Workers in the field of addressing prevention and awareness of sexual abuse produced from IO1.

A set of core requirements for undertaking the testing and validation of the youth peer training programme will be set out by Rinova in consultation with partners. However, given that precise contexts vary across the partner contexts, there will be maximum flexibility in the approach to piloting, particularly in terms of the ages of the youth peers, which may be clustered around different ages (e.g. 13 to 15 year olds, or 17-18 year olds) according to the precise context and orientation of each partner. Initially the Youth Peers will be identified and assessed using the partnership networks. A similar methodology will be used to recruit from partners and stakeholders to ensure as many young people as possible can be involved and to ensure there is no power imbalance

Task 4 Evaluation and finalisation

On completion of the testing and validation phase, the experience will be thoroughly evaluated, with agreed common indicators designed by Rinova and SoSu (as part of the Quality Plan). The evaluation will be extensive, comprising facilitated and interactive discussion and review sessions on the experience of participating in the training programme, using the learning resources and facilitating the youth peer groups (youth workers) as well as the facilitation of feedback and evaluation discussions with the youth peers on the experience of participating as youth peer volunteers.

Output Description (including: elements of innovation, expected impact and transferability potential)

The Keep Me Safe Mobile Digital Learning APP is a mobile learning resource that can be used both by youth workers and youth peers, in which the learning and content produced by the project will be digitised and contextualised, with new and complementary learning content and navigation guidance through a new user interface, accessible and utilised in mobile (laptop, tablet, smartphone) contexts.

Increasingly youth workers need to engage with millennials and the iGeneration where they are 'at', being completely familiar and indeed increasingly expectant to be able to use digital and e-tools to engage, communicate, participate and learn. Technology in education, particularly for youth work opens up a huge world of possibilities as to how ideas and learning are conveyed and shared, engaging with young people presenting different ideas, facts and theories. Learning that incorporates the potential offered by current technology enhances the learning experience and captures the minds of young people, whilst digital engagement platforms enable young people to explore their learning potential more widely.

Keep Me Safe is operating in an educational arena where there is limited Youth Peer activity in addressing sexual abuse amongst young people. Using a Mobile Learning App will enable the knowledge of partners, Keep Me Safe youth workers, and key stakeholders to be amplified, adapted and accessed in a different way to the action learning and development curriculum approach in which the detailed content and training materials have been developed. The Keep Me Safe Methodology – Youth Workers and Training Curriculum – Youth peer development developed in IO1 and IO2 represents a cultural shift in the approach to child protection. Bringing this to an APP platform will enable the pedagogical training and modular structure to be made accessible for the youth worker, youth peer, host organisations, partners and other stakeholders.

The Mobile Learning App will require brand new content and a completely new interface, mapping out new pathways and entry points to the content, while drawing upon relevant content developed through interactive exercises and learning content in the Keep Me Safe Youth Peer and youth worker training methodologies. The materials developed will be adapted in a new editorial framework for placing the materials in an appropriate navigational structure and interface in the APP online so that youth worker, educationists and wider child protection workers are in a position to access them in mobile locations.

Please describe the division of work, the tasks leading to the production of the intellectual output and the applied methodology

This IO will be led by SOSU Østjylland, which has a wide range of experience of developing professional and occupational resources onto digital platforms and its specific and wider experience of developing learning APPs and hosting on line learning systems, e-learning platforms and elearning

applications in a learning context. Under its specification and coordination, each partner will undertake the identification of requirements and resources for their country specific activities. Rinova will be responsible, with SOSU Østjylland, for developing guidance and templates for the production of platform materials, uploading, archiving. Hope for Children will work closely with SOSU Østjylland bringing its research practitioner/training provider perspective into the academic rigour, and input it into the mobile APP structure.

Task 1 - Specification

SOSU Østjylland will develop a specification for the APP design approach. This will include a full review of the digitisation to APP based access of key aspects of the content developed, thus far, for implementation through an action learning-based context, to one where this content, references and resources can be digitised in an appropriate way and accessed and navigated via the APP interface.

Given the realities of budget and the limitations of some delivery platforms, SOSU Østjylland will consider the technical requirements for the programme with agreed delivery devices and software technologies available.

The specification will also consider key messages and content to be included in the APP and an outline on module structure. It is likely to be based upon the use of HTML4 code (which works on all platforms: mobile and desktop) with HTML5 tags to allow video on the mobile devices. DreamWeaver is likely to be the main tool for designing templates and building customised content. As a demonstrator, the specification will also provide mock ups of initial screens (typically a menu, presentation screen, a question and a media screen).

Task 2 - Scripting

In order to ensure that all partners area able to contribute to the APP content design and production, SOSU Østjylland guidance templates will comprise a table format will be produced in a simple Word document format for scripts, utilising columns that may set out:

- Screen numbers
- Screen titles
- Screen text (this would include presentation text and all the questions (with items such as yes and no answers and feedback)
- Audio/video (if appropriate and links to relevant online sources
- Graphics (screen standard navigational elements and links to photo libraries)
- Developer notes (to explain how the whole screen works)

The scripting of content will be assigned across the partnership, with partners working together in specific topic areas and individually where appropriate to complete the scripts, drawing from the content in IO1 and IO2 and adapting and evolving it for the purposes of the scripts. While the precise way that the language dimension in the interface will be implemented will need careful implementation, scripting in this way will lend itself to the production of a multi-lingual APP.

Task 3 - Evaluation and finalisation

This event will serve both as a national stakeholder dissemination and promotional programme, and a multiplier event in the form of a conference with transnational inputs and perspectives from all of the project partners, who will be in Nicosia for the final transnational meeting that will be held coterminus (the day before or after) this conference. Impact

What is the expected impact on the participants, participating organisations, target groups and other relevant stakeholders?

Participant organisations: Will benefit from the transnational level of work, and exchange of knowledge and good practices in the partner countries. The Keep Me Safe Programme will increase the outreach of the activities of each partner and consolidate their presence at national level as key actors in the areas of capacity building, professional development, non-formal education and youth work with an emphasis on children's rights (as defined in the UNCRC), protection and empowerment contributing to the sustainability of the partners' existing work related to counteraction abuse against children and young people. Level 1 Participants, Youth Workers Through the Keep Me Safe Development Curriculum and Digital App, participants will gain an increased understanding, awareness, skillsets and knowledge in safeguarding the young people they work with, and in the development of a youth-led peer-to-peer strategy in addressing sexual violence issues that will ensure comprehensive protection. This professional development programme will enhance their employability. Level 2 Participants, Youth Peers Through the Youth Peer Keep Me Safe Training, participants will develop skills to provide concrete support to their peers in the prevention and counteraction of sexual abuse through raising awareness on the phenomenon, addressing disclosure and informing about existing support mechanisms, while benefiting from improved communication with a network of trained youth workers with recognised competences. Additionally, their media literacy and digital skills will be upscaled in that they will acquired targeted knowledge on using Keep Me Safe Digital App as a knowledge acquisition and transfer tool. Target Group 1, Youth Workers Post project completion, youth workers in Europe will benefit from the Role specification and ECVET Competency Framework (sexual abuse and awareness specialist) created through the Keep Me Safe partnership, as well as from the OIs resulting from the project which will be widely disseminated and made available by the project partners online and through their networks. Target Group 2, Young people Young people will benefit from the Keep Me Safe Peer network of Support emerging in all partner countries not only as beneficiaries of support but also as potential peer supporters trained by the youth workers and youth peers participating in the project. Further, the horizontal support system, will enable and facilitate them to adhere to a community where they feel protected and safe. Stakeholders Youth-led organisations will have access to the IOs of the project and will gain the necessary knowledge and guidelines to apply all the strategies and procedures that will make their youth safer, strengthening their mutual relationships, trust, respect and support. Public entities: the project will also improve the knowledge of national, regional, local authorities that provide support services children and young people victims of sexual abuse. The impact on the participating organisations will be twofold: (i) Sharing complementary expertise and (ii) Access to the Keep Me Safe methodology, training curriculum and learning tools. This will enhance their ability to offer specialised services in their community for individuals and other organisations closely working with young people. Through the empowerment of young people and the development of youth workers, Keep Me Safe will nurture a culture of peer-to-peer support for prevention, early detection, addressing and raising awareness on sexual abuse amongst young people.

What is the desired impact of the project at the local, regional, national, European and/or international levels?

The desired impact of Keep Me Safe is: At local, regional level: • Introduce a new horizontal layer (peer-to-peer) of safety and trust for the prevention, early detection, addressing and raising awareness on sexual abuse amongst young people; • Enhance existing procedures and methods by incorporating the peer-to-peer support and the development of youth workers and young people; • Sensitise youth on the importance of peer-to-peer support, trust and safe-keeping; • Increase the interest of the authorities in developing innovative tools and methods to support this new peer-to-peer safety layer; • Foster the use of Keep Me Safe learning activities among all youth-led and youth focused organizations; • Foster a debate on the promotion of Keep Me Safe practices and guidelines to raise awareness and structure recommendations to key streaming actors and, particularly, to influential and decision-making bodies; • Foster synergies between local and regional governments through a structured dialogue, regarding Keep Me Safe practices and guidelines, following current EU policies applicable to regional and territorial cooperation in these fields. At national level: • Tackle factors that keep victims from reporting incidents of abuse on time; • Decrease the rates of unreported incidents nation-wide; • Reduce incidents of sexual abuse against youth, through faster and direct intervention of peers with raised awareness through the Keep Me Safe programme. The Keep Me Safe will increase youth worker understanding, awareness and skillsets, ensuring they have the knowledge to safeguard. Peer interaction allows for credible social supportive relation, empathy, encouragement, and for an effective way of sharing knowledge through the experiential learning base. The Keep Me Safe project will use the role of peer support and influence to help youth understand and recognise signs of abuse among youth; • Strengthen the post-traumatic healing process and make it multi-faceted. The Keep Me Safe will increase youth worker understanding, awareness and skillsets, ensuring they have the knowledge to develop a youth-led peer-to-peer strategy in addressing sexual violence issues experienced by young people; • Increase the interest of youth to become an active safeguard to their peers; • Empower youth by creating a peer support network that offers emotional, informational, and associational support and actively involving them and including their voices and opinions in the training materials. At European and international level: • Contributing to the creation of a transnational support mechanism that will develop a horizontal and vertical sexual abuse towards youth protection system. The learning from the activities and the project results as OERs can be used by the wider European Youth sector as tested methodology and will activate the Keep Me Safe Youth Peer approach in other European countries; • At a policy level, contributing to the Council of Europe recommendation to better equip those working with young people with knowledge and practices to protect young people from sexual abuse, while equally empowering young people to protect themselves by making them aware of the risks of sexual exploitation and sexual abuse (CoE Convention on Protection of Children against Sexual Exploitation and Sexual Abuse). As well as providing a specific thematic contribution to the vision of the European Flagship 'youth on the move' and Europe 2020, Keep Me Safe also specifically addresses the need for training of professionals working with youth is also stressed in directive 2011/92/EU of the European parliament and of the Council of 13 December 2011 on combating the sexual abuse and sexual exploitation of children and child pornography, on prevention and training for professionals as well as the EU's recommendation on investing in youth [COM(2016) 940], by creating innovative opportunities to education and training, and for solidarity and participation; • Promoting youth empowerment through fostering youth's understanding and respect for human rights (namely the right to safety from harm, the right to participation, the right to non-discrimination stated in the UDHR and UNCRC).

How will you measure the previously mentioned impacts?

SoSu, as part of the Quality Plan will incorporate impact assessment in the iterative evaluation throughout the project and summatively at its conclusion. Impact assessment entails the application of a evaluation methodology that will take place at both the initial and the final stage of the project and will focus on the project's target groups. The Qualitative indicators designed by SoSu will include: 1) Outcomes of the validation process involving youth workers and youth peers; 2) Feedback from the target groups on Keep Me Safeapproach and methods in terms of usability, usefulness, relevance, clarity, state of the art, user-friendliness, practice-orientation; 3) Feedback from the final beneficiaries of the Keep Me Safe in terms of attractiveness, relevance, usefulness, usability, accessibility; 4) Measurement of outcomes regarding the improved ability to support young people during their transition from youth to adulthood; 5) The improved capabilities, as reported by the practitioners in the organisations and therefore the ability to provide better services. What will be the target groups of your dissemination activities inside and outside your partnership?

The partners will activate their well-established networks and contacts, which include among others national, European and international NGOs and networks; authorities and policy makers; social protection and child and youth protection stakeholders, specifically: a) Youth work organisations, youth clubs, educational institutions (schools, colleges, initial VET providers) and non formal youth providers and organisations that are providing community-based learning to young people that can embed the learning and content from Keep Me Safe into their educational practices and activities. As CEDFOP research has shown, guidance for young people remains an issue in London, whether it be in terms of organisational provision, the ability of their information, advice, guidance workers, trainers and tutors to provide it, or the way that young people relate to it in terms of accessibility and attractiveness; b) Youth workers, trainers, guidance practitioners, advocates, multipliers, facilitators, social workers, policy makers: Keep me Safe will offer an innovative, open, flexible learning solution, comprising an innovative action learning, youth peer development methodology, a Train the Trainer Guide, Mobile Learning App and a Service adoption Guide that can be used by these target groups for promotional and educational activities. Apart from this, the validation as part of the Intellectual Outputs through peer review, scrutiny, testing and evaluation allows for an opportunity to validate the learning acquired during the training. This will help evaluate the professional development of the participants and their learners. At local/regional and national level the learning opportunities and services will be available through the presence of the experienced partners and their experts and the use of the IOs and tools developed in the project, that will be embedded into their day-to-day provision of learning, development and support their network, regional companies and key audiences. The training materials will be included in the delivery database of their services as their educational programs for future implementation. All partners will have as key audiences youth led/focused organisation and associations, youth clubs, primary and secondary schools (public and private) for engaging them and raising awareness on sexual abuse, facilitated by expert perspectives from London Youth. The social work and medical associations and organisations targeting the protection of victims of sexual violence, safe houses for women and children, victims of violence are vital for the dissemination among front practitioners who are dealing with the issue and prevention programmes related to sexual abuse. See section below (i.e. if appropriate provide other dissemination information) for specific partner/country dissemination audience and stakeholder referencing. At the European level, HFC, which is coordinating the dissemination strategy and action plan, is a cooperating partner of the Council Of Europe for the implementation of the "One in Five" campaign; partner of the PROMISE partnership (on multiagency/multilevel cooperation in cases of sexual abuse against children, with partners in 11 EU countries including public entities, support services and NGOs); national operator of the European Helpline For Children and Adolescents (a network of 24 Member States, in which a number of non MS and candidate states participate); and hosts an International network of Academic Chairs of the UNCRC in 8 countries. It has actively disseminated its results in Cyprus and across Europe, raising awareness of the extent of sexual abuse and violence against children and young people. The approval of Keep Me Safe will provide an additional impetus to this strategic role as a cooperating partner of the Council of Europe. In addition, Rinova is a member of the Metrpolisnet EEIG, which actively promotes the results of its members activities and resources, and includes a number of organisations based in countries outside of the Keep me Safe partnership (e.g. Germany, Ireland, Italy, Finland, Austria), providing an extension to the European network represented in the Keep Me Safe partnership.

In addition, all the related outcomes in digital format of the project will be hosted on the servers of the partners who have extensive experience of developing and hosting EU project websites and leading dissemination with policy makers, urban networks and European level communications. Sustainability will be boosted by involving members of the target groups and final beneficiaries in the designing phase of the project as well as in the implementation phase. A critical aspect for securing sustainability is the extended network of partners which consists of several thousand organisations, the vast majority of which work in the fields of youth work, education, school education, training and VET. In particular the sustainability framework will focus upon maintaining, sustaining and multiplying the use of its outputs. Sexual abuse has significant detrimental effects on young people, leading to long-term detrimental affects that cause social exclusion in terms of negative impacts on mental and emotional health, development and wellbeing, throughout key parts of their lives with severe knock-on results. The prevalence of sexual abuse towards children and young people is a significant societal challenge in Europe, identified by UN Special Protection Measures (2003) and the Council of Europe Protection Convention (2007) (EIGE.europa.eu). Lampe (2002) found overall EU prevalence rates of 6-36% in girls and 1–15% up to 15% of boys under 16 (depending on variable definitions). More recently, the Council of Europe (2014) estimates between 10% and 25% of young people experience sexual abuse stating that 'available data suggest that 1 in 5 children in Europe are victims of some form of sexual violence'. The Keep Me Safe programme is built upon the foundations of the DG Justice funded JudEx+ project (2015-2017), which successfully developed a unique methodology and CPD training programme to create a child friendly judicial system throughout Europe developing the skillsets of judicial professionals working with children effected by sexual violence. Usually the weight of recognising signs of sexual abuse is given to adult figures: parents and guardians, as well as, primary care givers, teachers, mentors and community leaders. Initiatives aimed at tackling the situation tend to focus upon professional adults in their roles in addressing a young person's sexual abuse experience, developing the capacity of professionals or staff working with youth, investing mainly in people with a certain position of authority. Mobilising the JudEx+ ethos, best practice and achievements, the Keep Me Safe programme will develop a new transnational methodology aimed at the development and support of youth workers to both increase their own knowledge, awareness and safeguarding strategies within their own countries, while creating a youth-led Peer Support Network. It will empower young people's inter-support skills, providing guidance on how to manage when a friend makes a sexual abuse disclosure, what to do when this occurs, while also ensuring their own safety, preventing inter-peer abuse. The Keep Me Safe project will achieve this through the creation of three innovative intellectual outputs designed to increase the youth sector's knowledge, awareness and civic participation in addressing sexual abuse amongst 13 to 18 year olds - both at the youth worker level through comprehensive role and competency specification, as well as amongst young people through active peer-to-peer engagement, while formalising a unique training methodology/curriculum aimed at developing Youth Peers actively tackling sexual abuse. This pedagogical approach will incorporate accessible guidelines on the Keep Me Safe training programmes to youth workers, volunteers and young people, as well as launching the Keep Me Safe outputs on a digital mobile learning App and providing those with responsibilities for the design and funding of youth work provision, as well as those responsible for the CPD of youth workers. The Keep Me Safe programme contributes to the Erasmus+ Youth priorities of Promoting quality youth work and promoting youth empowerment, by developing a unique alternative pathway for early detection of sexual abuse as well as the prevention of sexual violence amongst young people. Through the development of youth workers and young people, Keep Me Safe will develop a peer-to-peer approach in addressing and raising awareness and preventing sexual abuse amongst youth. The

Keep Me Safe will increase youth worker understanding, awareness and skillsets, ensuring they have the knowledge both in safeguarding and in the development of a youth-led peer-to-peer strategy in addressing sexual violence issues experienced by young people. Peer interaction allows for credible social supportive relation, empathy, encouragement, and for an effective way of sharing knowledge through the experiential learning base. The Keep Me Safe project will use the role of peer support and influence to help youth understand and recognise signs of abuse among youth - addressing the Erasmus+ priority of Social Inclusion, empowering vulnerable young people to recognise and address abuse. Providing a horizontal support system by creating a Youth Peer methodology, validated by an empowered youth network in each partner country, besides the support framework of active and trained youth workers, Keep Me Safe will equip youth workers and young people with knowledge, skills and techniques about different types of abuse, and on how to identify abuse as an essential stage in safeguarding themselves and their peers.
