The inclusion of the elderly with intellectual disability (ID) in activities that improve both their health and their emotional well-being, entails specifically designed practices and policies to identify and eliminate the barriers that hinder their ability to participate in a full form in society. According to the UN, "Social protection has been significantly extended globally, yet persons with disabilities are up to five times more likely than average to incur catastrophic health expenditures". That is why social inclusion is one of the eleven priorities of the EU Cohesion Policy for 2014-2020 ("Thematic Objective n.9"), which includes promoting the social, economic and political inclusion of all people, regardless of their age, sex, disability, race, ethnicity, origin, religion or economic situation or any other condition.

To date, VET centers do not offer their students training itineraries strictly directed towards issues related to active aging of people with ID. Hence the importance of establishing training tools, quality technical content and adequate methodologies to enable VET teachers from Professional Families of Community Service and Social Health Care to receive adequate training.

One of the main results that we hope to achieve is the creation of a curriculum that improves the technical training of teachers of professional families directly linked to the target group, thus creating a flow of knowledge between teachers and VET students in the framework of attention to the elderly with ID.

The estimated direct impact will be of at least 100 VET teachers from these Professional Families from four different countries, direct participants in the training, and over 200 indirect participants among the professionals and workers of the different organizations that work with people with ID, with whom we will collaborate and for whom we the results and products derived from the project will be available.

AIDA project also seeks to achieve its results through an innovative methodology in the testing of all materials. Our team of external evaluators, made up of a group of professionals who work with older people with ID and their families (one per partner country), will participate in a non-formal way in the project. We will send them the materials and products generated so that, with their contributions, suggestions and ideas, they can help us implement all the necessary improvements for Call 2020 Round 1 KA2 - Cooperation for innovation and the exchange of good practices KA202 - Strategic Partnerships for vocational education and training (Form ID: KA202-6D1C5BD8 Deadline (Brussels Time) 2020-04-23 12:00:00 2 / 171EN) to create an online course of the highest quality. This online course will take into account not only the social health care of the elderly with ID but also the design of bio-psycho-social stimulation programs to be implemented by professionals working directly with them and prevent their physical, cognitive, emotional and social deterioration.

The activities planned in this project are:

- 1. Make a map clearly indicating what type of bio-psycho-social characteristics and needs the group of the elderly with ID present.
- 2. Identify, from there, the technical competences that VET teachers of professional families of Community Services and Social Health Care, as well as direct care professionals working with the elderly with ID, have to acquire to improve their professional training.
- 3. Design a curriculum for the VET of professional Families of Community Service and Social Health Care, as well as direct care professionals working with the elderly with ID, based on the study previously carried out and with quality content to improve training of VET teachers and professionals themselves.
- Generate an online training from the designed curriculum.
- 5. Pilote online training to improve its content and methodology based on the feedback provided by the participants themselves to achieve a course with the highest possible quality.

In this project, the concept of Quality of Life will be constant on each planned activity or intellectual result, developing materials with the maximum capacity for transferability and the greatest possible impact, not only on the target group but on society in general. We aspire for all participants in the project to focus their work towards a new conception of what the QUALITY OF LIFE OF THE ELDERLY WITH ID means.

#### Background and Experience

Centro San Vistor was founded in 1953 in the region of Encartaciones, in the province of Biscay, in a rural area where job opportunities usually pass through agricultural and livestock activity. Located in a mountainous area and with a rugged landscape, terrestrial communications present not a few difficulties that accentuate the lack of opportunities for the residents of the region.

Centro San Viator offers training from Kinder Garden to Formación Profesional Básica (EQF 3), Grado Medio (EQF 4) and Grado Superior (EQF 5) to meet the needs of more than 1000 students working with a staff of about 90 professionals. Our VET offer includes: Retail, Car Mechanics, Mechanization, Electronics-Electricity, Child Education and Gariatrics. We offer courses for unemployed people, in order to respond to the high percentage of unemployment that currently exists in this region. Complementing our offer, we also promote training courses for active workers.

We are a school with a strong social character and a priority objective: helping people with fewer opportunities, threatened by social exclusion especially children and youngsters with intellectual disabilities. CSV receives about 150 students a year who have been in the educational system which has failed them. We also have 5 classrooms with about 60 young students (aged16-20) who are mentally disable (slight-medium).

We have a department focusing on projects that ease the inclusion of different groups who are in exclusion (or at risk). From this area we implement tailor made training courses to increase the employability of these groups.

We are also accredited with Erasmus Charter for Higher Education and the Erasmus+ VET Mobility Charter.

Sosu Ostjylland is the second largest social and health care college in Denmark. We have just as coordinator finished a project developing and testing a short termed educational program for senior citizens. The name of the project was BEPRESEI – Better Preparation for senior Life. Educating elderly and staff related to elderly to understand the ageing process better and have to maintain and keep their physical strength and competences later in life.

This project was very online with the purpose and objective of AIDA.

As mentioned before we are authorized of short term supplementary training courses for the Labor Marked educational System in Demark, but at the same time SOSU Østiylland is also the biggers developer of these courses, curriculum, objective, content and methodology. Developing these courses takes always place according to a contract with Minister of Education in Denmark. So we are very experienced in developing curriculums for new areas in need to be upgraded, when it comes to enhance and strength the basis of knowledge and competences among staff. Further more we educate and train social and health care professionals and accordance with this task, we develop constantly training materials: traditional, web-based and game-based. In some cases, the students are co-developers of training material. What are the activities and experience of the organisation in the areas relevant for this project? What are the skills and/or expertise of key persons involved in this project?

Bridgwater & Taunton College has been participating in European projects for 12 years. The Erasmus+ programme is structured in two ways; staff and student mobilities (work/study placements and job shadowing in Europe) and subject specific European projects, which are embedded in the Curriculum teams. The Erasmus Team support all areas of the mobilities and projects. The College recognises that involvement in Erasmus+ helps students develop personally and professionally; that

Students gain valuable international experience, broaden their horizons, experience new cultures and discover new ways of working. Overall contributing to diversifying their way of learning. The Erasmus Team work closely with the College's curriculum areas to ensure that students who may need additional support to be mobile are fully engaged from the beginning. Students often need encouragement to undertake a period abroad, and as part of the pre-mobility support, the team deliver an information evening for parents and quardiens. The team also meet with students in

groups to enswer further questions – this approach has proven effective as students see that they are not the only ones interested in going abroad. When students return to the UK, they are invited to present on their experience to the rest of the group, which develops their public speaking skills and expands their network. Students are advised to keep a blog and take pictures during their trip to include in their presentation, encouraging them to be reflective during the mobility period. These activities expand their knowledge in becoming more independent, improving their self-confidence and overall encouraging them to be a successful learner. Hosting students and steff from around Europe is something that we feel is vital for contributing to the diversity of the College. Living in a rural area means that students and steff sometimes have limited travel experience, so enabling them to network and work as a team with people from different countries has given them the cultural awareness they need but in safe and natural environment. This aspect of Erasmus+ encourages social inclusion and gives them a broader understanding of the wider world, thus setting them up for their next steps. During 2017/18, a total number of 24 students were involved in a mobility or a project. This number has kick-started the want for Erasmus+ opportunities at the College and has enabled staff to see the scope Erasmus+ has for their learners. The Erasmus Team is made up of the External Funding 8. Bid Manager EU and the Project Co-ordinator. They work closely together to ensure all project deliverables are met and are responsible for all KA2 and KA3 projects currently at the College. The Team is the key point of contact for all Curriculum staff and students and ensure that mobilities are carried out successfully.

Foundation studies students come from a range of abilities and backgrounds.

We work with young people who have profound and multiple learning and physical disabilities, these students tend to follow the specialist school process and then come the BTC to engage with courses that are bespoke to their needs, the courses we run are mainly self-occupancy style courses. We then have students who may have a diagnosed or undiagnosed learning disability; we work with these students by developing their confidence in their skills to lead either a more independent life or a life where they can engage with voluntary or paid employment, leading to a fulfilling life.

We then have students who suffer with various mental health linesses, these students vary from anxiety and have come from being home schooled and not been in any formal education, for long periods of time, to students who have depression and need support from the class tutor to the College wellbeing team, we have specialist support services to support the students to engage and grow in confidence and then progress onto cross college courses.

We have students that due to their family and financial situations they have not had the benefits or successes of their peers, as a team in foundation studies we try to build resilience and confidence that they can improve their lives.

For decades we have dodged the fact that kids with intelectual disabilities (ID) will become teenagers and adults with ID, but we've never thought that someday they will also become elderly people with ID, probably because their life span has always been lower than general population's life span. Different international researches are noting that the aging of people with ID differs from the aging of people of similar age among the general population. That's why it is necessary to adjust the care and treatment that they receive to their own characteristics and needs. The European Union propose the inclusion of people with less opportunities in society as one of the Millennium Development Goals.

As VET centers, we should update our education programs to the new necessities society has. Our priority is to improve the quality of VET, offering the teaching staff and field professionals the opportunity to train in the framework of care for the elderly with intellectual disabilities, so that the knowledge acquired can, therefore, be transferred to their students. To do this, we will create a working group, with relatives of the elderly with ID, direct care professionals working with them and teachers, who wil transmit their specific knowledge to us for the validation of both the curricular content and the online training itself. They will be our external evaluation team, allowing us to make all the necessary adaptations and modifications to guarantee the quality of the course.

The impact that this online training can have will be significant, not only for vocational training centers but also for all those entities, organizations and residential services that provide direct care to the group of elderly with ID. Our goal is to design an online course with content which addresses from an integral perspective the needs and characteristics of the group in all its complexity, and the bio-psycho-social needs of older people with ID. In addition, the fact that the training is online will help teachers to create their own digital material for the future when they will give lessons of the course to students, which will facilitate the transfer of knowledge and favour alternate training (DUAL).

The Coronavirus pandemic has highlighted the value of online training, which is already a fact of undeniable relevance. Therefore, it is essential that schools have the ability to adapt to digital technologies to facilitate access to knowledge for students.

### Project Description

Please explain the context and the objectives of your project as well as the needs and target groups to be addressed. Why should this project be carried out transnationally?

This project was born from the need to address the fact that people with intellectual disabilities (ID) are getting older and that there is currently no specific training in Vocational Training (VET) centers to care for them.

The current generation of people with ID is the first one to reach an advanced average age. Several studies have found that an overwhelming majority of older people with ID experience problems related to their physical and mental health, including cognitive decline. There is a risk of underestimating these issues, and the WHO has drawn attention to the fact that people with ID who reach old age do not have the same opportunities for healthy aging as the general population, largely due to a lack of trained professionals.

It is our responsibility to promote the inclusion of people with disabilities in society and for this, it is important that the professionals who work with them are as well trained as possible. Vocational Training centers can greatly influence our students to acquire the necessary skills to respond to the inherent needs of the group.

In the previous analysis carried out by the project partners, we have seen how the training deficiencies are similar in all our countries, although the approach we give to training is different, which is why we have decided to carry out this project transnationally, seeking complementarity. Countries from 4 different cultures with different mentalities and sensitivities we will work on creating a common curriculum.

Our direct target groups are those to whom the training will be intended: teachers of the socio-sanitary area of VET centers and direct care workers with people with ID. But the indirect ones are many more since we hope to improve the quality of the VET offer, thus improving the education of the students. The elderly with ID will see the quality of their life improve due to a better preparation of their caregivers, thus improving the lives of their families, too.

The objectives of this project are:

- 1. Draw a map that clearly indicates what type of bio-psycho-social characteristics and needs the group of the elderly presents different from those common to the whole group, in order to improve their quality of life.
- 2. Identify, from there, the technical competences necessary for VET teachers of the Community Service and Social Health Care families, as well as Direct Care professionals who work with the elderly with ID, to improve their professional training.
- 3. Design -based on the previous study- a VET curriculum for professional Families of Community Service and Social Health Care, as well as for Direct Care professionals who work with the elderly with ID, which will contain quality content to improve training of the VET teachers and the professionals themselves.

- 4. Generate online training based on the designed curriculum.
- Pilot the online training to improve its content and methodology based on the feedback provided by the participants themselves- in order to achieve a course with the highest possible quality and adapted to the needs of the elderly group with ID and the target group.

### What results are expected during the project and on its completion?

We must adapt the support for the elderly with ID to the needs of the individual and strengthen the individual's ability to live a life with the highest possible quality. For this, it is essential to have qualified professionals, which is hindered by the absence of structured training plans in VET centers. The right to an active life with support and to participate in the centers of daily activity adapted to the needs of this group necessarily entails that training centers activate a bio-psycho-social curriculum to try to alleviate the physical and cognitive deterioration that occurs with the passage of time, especially in this group. This requires knowledge not only of the specific needs of the particular person with ID, but also of the aging process and age-related issues. Therefore, it is important to have a well-structured curriculum.

The results that we are going to achieve with this project are:

- Improve the specific technical competences of the VET teachers of the Community Service and Social Health Care families to support and achieve the students training to work with the elderly with ID.
- Generate didactic tools for teachers to facilitate the transfer of the knowledge acquired in the received training to their students.
- Improve the existing knowledge about the characteristics and specific needs of the group of the elderly with ID and the understanding of their specific needs.
- Create a curriculum to improve the specific technical training of the teachers of the Professional Families of Community Service and Social Health Care to achieve the improvement of the quality of life of elderly with ID in all areas of life (bio-psycho-social)
- Create a flow of knowledge among teachers who train students in the Community Service and Social Health Care families.
- A web page of the project which offers the possibility of downloading for free all the developed materials, as well as the complementary materials. In addition, our website will contribute to the dissemination of the project. We will also publish a brief triptych of the Project, offering general information about the project in all the languages of the project partners, which will be sent to as many public and private entities and organizations accounts as possible in each of the project's partner countries.
- Offer all partners the opportunity to implement the results obtained in intellectual outcome 1 (Identification of the specific characteristics and needs of the elderly with ID). We will carry out a short training which will include learning, training and teaching activities. We will also offer participants the opportunity to find out on-site what the needs of the group are and learn from the professionals who work with the elderly with ID and who will convey to us what their needs are in terms of professional training. 2 people from each of the partner organizations will participate in this training except for ERROTU, who will participate with only one person.





In the "Intellectual Results" section we will provide more detailed information on the expected results, linking them to the intellectual results and to the final products and results.

In what way is the project innovative and/or complementary to other projects already carried out by the participating organisations?

The innovative nature of this project is defined by the creation of a new training curriculum for the training of VET teachers from the professional families of Community Service and Social Health Care. As we have described in the previous section, the number of elderly with ID is growing exponentially in Europe and so is the existing need in all EU countries to train Direct Care professionals who work with the elderly with ID.

Although the training of VET teachers is something present in many other projects, the central theme of this project might be the most innovative part of it. The care of the elderly with ID has traditionally had a care approach where only their basic needs were met, without attaching the importance their emotional, social and personal deserve. Active aging is on the basis of this project, with an innovative theme seeking to train in active prevention and comprehensive care for the person to achieve an improvement in the quality of life.

The treatment of the special educational needs of children and young people with ID and even their access to the labor market are topics on which we have been able to work in other projects such as KA2 VET4ALL, or even training professionals who work with refugees as in the KA2 SCORE project.

As far as we know, this is the first project aimed at developing a VET curriculum to train teachers in this area, with the aim of providing with quality training that can be transferred to the classroom and to students; and subsequently implementing the acquired knowledge in organizations and entities working with the elderly with ID.

For all these reasons, it is necessary for the EU to provide funding to allow the development of curriculums -such as this one- which establish the necessary tools and skills for VET teachers, social organizations, and public and private entities to design full action plans with the elderly with ID. The AIDA project makes an INNOVATIVE contribution to the above question by also providing:

- A curriculum model that does not exist for the training of VET teachers as well as for professionals who wish to expand their training with the group of the elderly with ID. This can be reflected in the 2016 study from which the Millennium Goals are fed: "Social protection has been significantly extended throughout the world. However, people with disabilities are up to five times more likely to face catastrophic health costs".
- A network of VET centers, organizations and entities working in the framework of disability at EU level sharing common needs and interests to promote the inclusion of people with disabilities in society, regardless of their age.
- The possibility of evaluating the usefulness of the designed curriculum through the participation of professionals and relatives of the elderly with ID who voluntarily participate in the project. We want the curriculum to respond to the training needs of future professionals who work with the elderly with ID. Therefore we believe that it may be very interesting for professionals themselves and even relatives of the elderly with ID to validate it.
- An improvement in the curricula of VET centers, especially in the Community Service and Social Health Care families.

- We will give an innovative comprehensive approach to the treatment of disability from a bio-psycho-social perspective, prioritizing the right to participation of the elderly and being protagonists of their own lives.

How did you choose the project partners and what will they bring to the project? Does it involve organisations that have never previously been involved in a Strategic Partnerships project?

Centro San Viator works on different projects with the rest of the partners with a shared concern for people with ID when they age. From these conversations and from the attendance at different forums about ID we came to the conclusion that all 5 partners are concerned about the lack of training for education professionals and that a European project could help us find a solution.

The criteria established for the selection of partners were the following:

- That all partners should have as part of their daily work and their objective to work to offer to the most vulnerable groups mechanisms that improve their quality of life.
- That the way in which the partners were organized and their way of offering non-formal learning / education / training activities to the elderly must be different and complementary to each other.
- That all partners had different experiences and special skills necessary for a successful implementation of the learning results and objectives of this project.
- That all partners had experiences in the innovation of learning / education / training activities linked to vulnerable groups, especially people with ID.
- That the majority of the partners had experience in managing EU projects.
- That all partners had access to different solid networks, forums and spaces where they can disseminate the project both nationally, like EfVET.

In addition to Centro San Viator, which has extensive experience in managing both national and international projects and the knowledge of a VET working for the inclusion of people with special emphasis on people with ID, the consortium is formed by:





ERROTU They fulfill all the priorities and besides, they will be the main partner contributing the specific knowledge. In recent years, Errotu has been developing numerous projects with the aim of improving the quality of life of elderly people with dementia or similar problems

C.M. SKOULIDI & SIA EE, from now on P-CONSULTING, brings many years of experience in the identification, communication, promotion and preparation of all kinds of elearning training so that our VET teachers can be adequately trained in active aging of the elderly with ID. As the main objective of this project is to offer educational / training programs through an online course, the knowledge and experience of P-consulting will be central and important. Beyond that, the Greek partner has experience in planning dissemination strategies and processes, and has done so in different EU projects over the last 5 years.

BTC is deeply involved in offering a host of different activities for people with disabilities and for many years has focused on this collective in very different ways. They have experiences in developing formal and non-formal curriculums which combine learning / education / training activities with interactive learning activities. It will be a key partner in the development of one of the key results of this project: the piloting of training for the VET teachers of the Community Service and Social Health Care families.

SOSU-AARHUS will provide content to the curricular design, offering the knowledge that exists in Denmark on issues related to active aging and its experience with regard to the bio-psycho-social problems of the elderly with ID and the health promotion of the elderly in general.

In October 2019, representatives of the 5 partners met during the EfVET conference in Portugal to begin planning the project and since then we have held several online meetings. At the first physical meeting we agreed that Centro San Viator should be the applicant due to our experience coordinating projects like this.

Together, we have established a strong team of highly experienced and supportive partners. All partners know each other and, although we have never done a project together, we trust each other and we know each other's strengths and weaknesses.

#### How will the tasks and responsibilities be distributed among the partners?

This project is led by a partner - CSV - with experience in the management and coordination of both national and European projects, with special knowledge of the European inclusion networks where we are reference. We have an International Relations Department from where we coordinate all the internationalization actions of Centro San Viator. We are also a benchmark in the Basque Country and in Spain in advising KA1 mobilities for young people with ID or school failure. We are, therefore, an entity committed to inclusion and willing to lead a new innovative project that attends to the needs of a group that all project partners know very well: people with ID, especially over 45 years old, which is when a person with ID is considered to begin to age. The management of the entire project, its tasks and dissemination will be carried out in a consensual and collaborative way, which means that although there will be task leaders / IOs, all the partners will work on its realization.

Centro San Viator (CSV) will be responsible for the direct management of the project and its dissemination, for which it will generate a management manual in English so that partners know what to expect. This manual will cover, for example, conflict management or how communication will be between partners and stakeholders. The center will also carry out a strict control of the compliance by the partners of each of the tasks related to the proposed Intellectual results. Likewise, CSV will ensure that:

1. All partners and their partners in the different national networks in which they participate are regularly informed of the progress of this project

- 2. All the partners can carry out the individual tasks assigned to them, without forgetting that, as a team, it will be everyone's responsibility to collaborate to ensure that all tasks are executed within the deadlines agreed by all partners
- 3. Guarantee the existence of a clear and constantly updated work plan that allows us to produce all the planned results and products in due time, and that even allows us to have a margin to produce high-quality products.

Our intention is to divide all the results and activities as equitably as possible, taking into account the different competences and experiences of the partners, and giving each one the tasks that most closely match their competency profile in order to obtain the best possible results.

ERROTU will be responsible for carrying out the QUALITY MANAGEMENT PLAN to guarantee the success of the Project, as well as the corresponding evaluations and measurement of the impact of AIDA.

ERROTU will also be responsible for INTELLECTUAL RESULT 1: the strategy: it is necessary to identify the characteristics and needs of the group of elderly people with ID.

CSV will be responsible for INTELLECTUAL RESULT 2: The design of the curriculum of the online course for teachers.

P-CONSULTING will be responsible for the INTELLECTUAL RESULT 3: the Platform for the online course and testing the course of the platform until optimal operation is achieved.

SOSU will be responsible for INTELLECTUAL RESULT 4: the management of the online course with VET teachers from the Social Health Care and Community Service family, as well as the subsequent collection of the reports from each country and the preparation of a single final report.

BTC will participate as a VET center in the piloting carried out in Intellectual Result 4, in addition to being a co-creator in the different planned Intellectual Results. Additionally, this partner will be responsible for the proofreading of the project.

If relevant, please identify and explain the involvement of associated partners, not formally participating in the project. Please explain how they will contribute to the implementation of specific project tasks/activities or support the dissemination and sustainability of the project.

This project will have non-formal partners from several of the project partner countries. In Spain we will have the support and advice of entities such as the Lantegi Batuak Foundation or the ONCE Foundation as well as the explicit support of GORABIDE (we attach a letter of support). All of them are social entities that work with the group of people with ID from childhood to old age.

The current circumstances produced by the Coronavirus have meant that the letters of support from several Spanish entities, as well as from another British organization, haven't arrived in time. They will be promptly sent in case of approval of the project.





In the specific case of Gorabide, it is a non-profit association, formed by families, which aims at giving support to people with intellectual disabilities in Bizkaia -as well as their families and guardians- to improve their quality of life and defend their rights. The ultimate goal that gives meaning to Gorabide, driving all the activity of the association, is the defense of rights that -as members of society- people with intellectual disabilities have, regardless of the cause of its origin. At present, it has more than a dozen day centers and residential services where they provide direct care to young people, adults and the elderly with disabilities. During these years, Gorabide has been working so that people with intellectual disabilities are considered full members of society. And it has done so with the shared effort between people with ID and their families, professionals, volunteers, and public and private institutions. Throughout this trajectory, the needs of people with ID and their families have been detected, and creating services that have contributed to consolidating the social system of public responsibility. Even in the labor field, since the creation of Lantegi Batuak in 1983; and with the necessary tutelary support from the birth of Futubide in 1991; entities both promoted by Gorabide. Therefore, it is committed to AIDA by contributing its good work and its experience in working with elderly people with ID as well as to carry out dissemination tasks among its work networks and website, making its professionals and users available for the necessary piloting of the generated products.

In Denmark we have a very important collaborating entity. The VINTERVEJ RESIDENTIAL COMMUNITY 67 (we attach a letter of support), located in the municipality of Aarhus (Denmark) offers special care services for citizens over 40 years of age, who have various age-related innate or acquired disabilities and who require continuous support. They have 36 residents, divided into 5 groups of apartments. The youngest resident is 67 years old and the oldest is 88 years old.

In addition, they develop a work focused on resources and based on the concept of the Common Professional Foundation, The residential community Vintervej 67 works according to the principles of EDEN, which seek to eliminate loneliness, isolation and boredom.

The residential community Vintervej 67 will act as associate partner in the AIDA project with the following roles and tasks:

- The Vintervej 67 Residential Community, in cooperation with SOSU Østjylland, will provide current Danish knowledge and good practices on active aging for people with intellectual disabilities.
- In addition, the Vintervej 67 Residential Community will pilot the results of the project; and participate in the dissemination of the project's results in our professional networks; through our channels, instruments and institutional tools.

In Greece we have the support of a social organization called O Koi.Σ.Π.Ε. "FAROS", a social cooperative with limited responsibility (we enclose a letter of support for the project) that develops its work with the group of people with disabilities, helping them in their socio-labor insertion processes and providing support and assistance when they reach the Third Age. Its main objective is to develop activities aimed at improving the quality of life of people with disabilities who, on occasions, are also at risk of social exclusion.

These entities will help us to identify exactly the training needs of their professionals so that we can design and implement a curriculum for teachers as close to the real needs of the entities as possible. It is also important to point out that these entities will also help us in Spain to point out the main characteristics of the elderly with ID as well as to identify their emotional, physical, health, cognitive and social needs.

All the project partners are in one way or another in contact with the people to whom this project is directed: VET centers with teachers from the Social Health Care and Community Service families and companies working with the elderly who are the most vulnerable, specifically the elderly with ID. In addition, CSV, BTC and SOSU have extensive experience working with the group of people with ID through different national and European programs of joint cooperation, so we have a close relationship with organizations that offer residential services and care for the elderly with ID.

There are several direct participants in this project:

- All project partners whose participation will vary depending on their responsibility for it.
- Entities, organizations and professionals whose professional work focuses on working with the group of the elderly with ID. Not only will they be one of the target groups of the online training, but they will also take an active part in its development.
- Teachers of the professional families of Community Service and Social Health Care. Like the participants of the previous group, teachers will take part in the generation of the online material for the training and will also be participants in the training itself.
- Professionals in the field of intellectual disability, who will contribute with their knowledge to the preparation of the training and to its delivery
- Relatives of elderly people with ID, who will be part of the group to evaluate and improve the materials generated for the training of professionals.

The indirect participants of this project will be:

- VET students, who will receive better training in the field of Care for the Elderly with ID by having teachers trained for this purpose.
- Professionals who work with the elderly with ID and their relatives, who will be our external evaluation team.

Please provide detailed information about the project activities that you will carry out with the support of the grant requested under the item 'Project Management and Implementation'

All the actions related to coordination will be carried out with the responsibility of each of the partners, with whom we have worked in the framework of other Erasmus + projects and have all the credibility of Centro San Viator. On the other hand, as the ultimate responsible for it, we will carry out the monitoring and control of each and every one of the tasks, results and products obtained throughout the project.

The grant will cover the costs of administration, management, operational meetings, coordination and communication between partners, as well as of the meetings, which will held via Skype or similar virtual cooperation, and local project activities, and the costs of the services of the personnel in charge of the accounting.

Our project has a duration of 26 months and during this time, the management will be carried out in a transversal way: including all coordination actions, administrative and financial management, guality control and evaluation, dissemination products and activities and tracing.

Centro San Viator, as responsible for the project, will ensure the correct performance of each and every one of the project actions, trying to achieve the best possible results and products, the performance of all the activities planned in the agreed times, as well as the correct presentation of reports respecting the budget approved by all partners. The adoption of a single common format will allow Centro San Viator to collect all the received information. All this will help the Finance Department to keep accounting as agile and clear as possible, presenting the accounting information and corresponding reports to the partners and the national agency in the clearest possible way.

#### Transnational Project Meetings

Transnational project meetings: how often do you plan to meet, who will participate in those meetings, where will they take place and what will be the goal?

Throughout the project we will hold -with all partners- 4 meetings, where all aspects related to the organization of the activities and planned products will be discussed, including the project implementation plan, the objectives to be achieve, the tasks of each partner, the control and quality activities, dissemination and exploitation and impact, as well as other issues related to the project that may arise.

Therefore, the planned meetings are the following:

- 1- The first meeting is scheduled for November 2020 in Greece. Current circumstances have caused us to slightly modify the planned calendar and for our project to start with a virtual meeting so as to postpone, at least, until November the first face-to-face meeting of the project. This will be attended by 2 people per partner country, except Errotu, which will send 1 participant. During the first face-to-face meeting, we will share the work done so far by each partner and we will make sure that all partners fully understand what the challenges to be achieved and the objectives of the Project are, as well as what the role to be played by each partner is based on the objectives and expected results.
- 2- The second meeting is scheduled for June 2021 in the United Kingdom, where topics on the complementary materials of the course, the curriculum for training in technical skills of VET teachers and the design of the e-learning course will be discussed. This meeting will be attended by 2 participants per member, except Errotu who will participate with 1 person.
- 3- The third meeting is scheduled for January 2022 in Denmark. The third meeting will be held when the curriculum for the e-learning course is already defined and the online course for VET teachers is ready to be piloted among the teachers. In this meeting we will proceed to check the aforementioned and we will also begin to define the piloting that we are going to carry out of the course with the teachers. It will be necessary to have a meeting at that point, because the partners will have to discuss the organization of the piloting and the reports to be made. In addition, all partners must agree and organize the procedure for selecting the most appropriate teaching staff in each center. This meeting will be attended by 2 participants per member, except Errotu who will participate with 1 person.
- 4- The fourth and last meeting is scheduled for September 2022 in Spain. In the fourth meeting, the results of the online training piloting, the reports made by each partner, as well as the evaluation of the online training itself will be discussed. In addition, this will be the final meeting where the final conclusions will be discussed and a multiplier event will be organized for the dissemination of the results (final conference) in which all the partners will participate. This meeting will be attended by 2 participants per member, except Errotu who will participate with 1 person.

In parallel, all partners from the same country will have monthly online meetings to learn about the activities that each partner is developing and jointly organize future activities.

### Project Management

How will you ensure proper budget control and time management in your project?

The financial management of the project is a fundamental aspect of it and is directly related to the success of its development. In this project, there will be a person, Estela Arkarazo, in charge of carrying out all the economic coordination tasks, who will deliver and monitor all the financial controls of the project and will advise the partners in the presentation of expense reports, etc. The partners must submit quarterly financial reports and the templates that show the hours that each partner allocates to the fulfillment of the project objectives (Intellectual Outputs)

Estela Arkarazo has been a staff economist at the San Viator Center for more than 5 years with extensive experience in the design, monitoring, management and evaluation of European projects within the ERASMUS + framework.

The project coordinator (Alfredo Garmendia) will keep the project partners regularly informed about the current status of the project and will be in charge of all matters relating to contracts. He will also be ultimately responsible for carrying out adequate time and budget management.

Therefore, all partners will receive support from the project coordinator to facilitate the work to be done in each of the partner countries. This will include all the financial documents that are necessary, as well as the instructions that are precise on the use to which the corresponding financing of the project is destined.

Although the project coordinator will be in charge of the financial management of the project, it is necessary that all partners help in the development of the project, agreeing on the financial methodology necessary for the project. The project coordinator will also ensure that the goals and objectives are carried out successfully by being carried out on schedule and within budget. This will be reflected in an intermediate report midway through the project and will also be discussed in all partner meetings, with individual online meetings being held when the coordinator or one of the partners deems it appropriate. At the end of the project, a final report will also be presented in which all the results and products of the project will be collected, as well as other economic, dissemination, impact or management issues related to it.

Each transnational meeting will have a clear agenda and after each one, the minutes of the meeting will be sent to each partner, where the most significant and relevant aspects for the project will be collected. There will also be a list of actions that will be delivered to the partners, who will be responsible for delivering each of the project results on the dates set.

The project management will pay special attention to communication between meetings, their preparation, the development of guidelines for each step of the project and the organizational support of the different events that take place in each country, based on the established guidelines. in the Project Work Plan that will be approved at the initial meeting. In addition, a schedule will be established that will be a living document and will be reviewed during the implementation of the project.

Thus, the project coordinator will be responsible for:





- track budget expenses.
- supervise the development of the activities foreseen in the work plan and guarantee the management is carried out in accordance with the European Commission standards. carry out the assigned activities, together with the other partners.
- Ensure that the project time justifies and adequately documents in the corresponding model.
- Take all necessary corrective measures to meet the project objectives.

How will the progress, quality and achievement of project activities be monitored? Please describe the qualitative and quantitative indicators you will use. Please give information about the involved staff, as well as the timing and frequency of the monitoring activities.

CSV is very aware of the importance of obtaining results and products of the highest quality while also implementing activities in the same line. To ensure the quality of the project, the partners will work together under the leadership of Errotu, a company with more than 12 years of experience in project management and consulting and which has managed several R+D projects, both national and international. In addition, he has received training and has been responsible for the UNE ISO 9001, 17001-2 quality systems in different companies. Quality management will be one of the key points to be discussed among all the partners in all the meetings, with specific issues to work on in each of the meetings. In addition to all the measures that will be adopted, all partners have experience in ERASMUS + projects and most of them are certified according to European ISO standards, so we will also ask them to implement internal actions aimed at keeping project activities under control and manage activities in accordance with quality procedures. It will be each partner who is responsible for appointing the most appropriate person within his management expert staff to collaborate in this project.

A Quality Management Plan (QMP) will be developed at the beginning of the project and agreed upon at the kickoff meeting. This plan will include:

-The individual report sheet and other necessary documents.

To ensure that we achieve optimal quality standards, the following tasks will be included:

- 1. Collect the expected results and the results of the intellectual results
- 2. Check the timeline and resources for each objective that leads to results
- 3. Create the indicators for different objectives
- 4. Schedule specific moments in each meeting of the project to decide the actions that are necessary according to the results that the indicators are showing
- 5. Compile the information that is necessary to prepare the intermediate report or the final quality report
- 6. Produce a quality report after the first year of the project and a final quality report at the end of the project

Project meetings will be evaluated by all participants. The internal evaluator will create a questionnaire to be used in all meetings for evaluation. At each project meeting there will be a Quality Report to report on performance: degree of compliance with procedures, objectives and results. A quality report will be prepared for the intermediate and final reports.

The most significant moments in this process with their corresponding indicators will be:

- 1. Evaluation Process (E)
- a) Preparation of a quality management manual by Errotu and CSV in the first 3 months of the project. The indicators are: information on the selection of E instruments, the procedures to be followed, the products to be obtained and the final results, all reflected in a timetable with a clear definition of the quality criteria
- b) E follow-up reports: one per meeting and will be prepared by Errotu and CSV. The indicators are: an E per partner with ratings from 1 to 5, aspects related to the development of the meeting, as well as in relation to the transnational meeting (adaptation of the meeting agenda, organization of the trip and logistics, contribution of all partners, analysis of deviations from what was planned, ...)
- c) Intermediate E Report: it will be prepared by CSV at the end of the first year of the project. The indicators are: a comparative report of the first year of the project of the meetings held and of the different phases of the same, the products developed and their quality, as well as the dissemination and impact
- d) Final E Report: prepared by CSV at the end of the project. The indicators are: 1. A comparative report of the entire project period on its process (meetings and phases), products developed, dissemination activities and impact. 2. Evaluation reports (IE) a) IE of the contents of the online course: it will be prepared by CSV after piloting the training





course from the questionnaires completed by the participating teachers. The indicators are: level of satisfaction of the participants with regard to the contents, materials, methodologies, duration, technical skills, etc.

What are your plans for handling risks which could happen during the project (e.g. delays, budget, conflicts, etc.)?

All partners in this project have a lot of experience in European projects linked to Erasmus +, in addition to having all the skills and competencies necessary to develop and deliver high-quality products in accordance with what is described in the budget established in this project.

All partners also have experience in managing the different contingencies that occur throughout the project. This means having the capacity and the will to put the necessary resources to achieve all the objectives that are planned.

At the first meeting, the coordinator will present to all project partners a work plan with a clear timing of each and every one of the activities, expected products, and expected results throughout the project to ensure that all partners know the timetable and deadline for the different outcomes and activities. The coordinator will also emphasize the importance of long-term planning so that all partners and staff involved in this project will have an opportunity to adapt this project to all the tasks that the project staff have in each of their project's post.

With regard to intellectual results, all partners have participated in the development and completion of similar intellectual products in many other national and international projects.

To minimize the risks we will implement the following measures:

- 1-Delay in achieving planned objectives or reassignment of unanticipated tasks:

#### Implementation

The management and implementation of the project consist of three main areas:

- 1) Management and coordination of the project and its intellectual results.
- 2) Quality management.
- 3) Diffusion and exploitation.

The objective is to implement the work plan as planned and keep the project under control, including the planned activities, the organization of work, and the activities for quality management.

1. Project management and coordination includes financial administration of all project activities of partner organizations, financial management, including mid-term and final project report, communication between partners, organization and holding of transnational meetings, including the agenda and meeting minutes. The project management will be led by CSV, with extensive experience in carrying out this type of tasks in other national and European projects. Each activity planned in each intellectual result leads to its achievement and its achievement is the basis for the next intellectual result, meaning the correct and complete execution of each task is a sine qua non condition for the achievement of the project objectives.



- 2. The quality management is closely related and will be directed and supervised by Errotu, in collaboration with Centro San Viator. - 3. DISSEMINATION AND EXPLOITATION: it is the responsibility of all partners to carry out the implementation of the plan for dissemination and exploitation of results. That is why all the partners, together with the entities that are closest to them and collaborate peripherally in the project, as well as public and private organizations that collaborate with the partners, make a wide dissemination of the project, not only of the products. and final results but in a transversal way throughout its entire life. The exploitation actions will be carried out in parallel with the dissemination activities to guarantee the good use of the products and results in the future. P-consulting will be responsible for the management of the dissemination activities. Based on the developed dissemination strategy, the specific activities will be implemented. This project has a duration of 26 months, during which we will carry out extensive dissemination work and a final conference to be held in September in Bilbao, discarding the middle of July and August, which are usually non-working periods in many European countries. The project takes a dynamic approach to the needs of each of the partners to ensure that the needs of the target groups are satisfied. This is going to be carried out as follows: this consortium is a strategic group that includes the target groups themselves, since it has VET centers such as CSV, BTC and SOSU with teachers from the Social Health Care and Community Service families. In addition, Errotu is a partner whose entity has the elderly people with disabilities at the base of their daily work through the adaptations that it implements to improve their quality of life. On the other hand, p-consulting has more than 8 years of experience in the design and implementation of online training within the framework of European projects. This not only ensures that user needs are satisfied, but also contributes to the sustainability of the project by ensuring acceptance of the results and impact also on the consortium's

How will you communicate and cooperate with your partners?

Communication and collaboration will take place using a platform agreed by all partners, for example Dropbox or Drive. This project starts from the identification of the NEEDS and specific characteristics of the elderly with ID. This will be the basis on which we will build the curriculum that will train the VET teaching staff of the professional families of Community Service and Social Health Care. To do this, we will start by creating a questionnaire for data collection that will be completed by at least 20 professionals from each country (which will be our DIRECT TARGET GROUP in this intellectual result) who work with elderly people with ID or have a direct link with intellectual disability. , as professionals of day centers or nursing homes with the presence of people with this profile. These data, together with the documentary analysis of the needs and characteristics of the elderly with ID in each partner country, will be analyzed and collected in a report for each of the partner countries. It will then be included in a general report that will serve us as a base for all the products that are generated throughout the project. In all the project partner countries we have previously identified the existence of a common need: to know what the needs of the elderly people with disabilities are in order to adequately train the professionals who work with them daily and to be able, in this way, to significantly improve their quality of life.

The objective of this study is to draw a map that clearly indicates:

- what kind of bio-psycho-social needs the group of the elderly with ID presents.
- What the main characteristics of the elderly with ID are and which are different from the characteristics common to the entire group.
- To identify from there, the technical skills that professionals working with the elderly with ID have to acquire.
- which the most appropriate ergonomic and cognitive accessibility adaptations to respond to the identified needs are.





The IMPACT that this intellectual result will have on the project is key, since this information will be the basis on which other intellectual results developed later will be piloted. In addition, other VET centers, entities and associations that work with the group of people with disabilities can benefit from the collected information, since it can be easily TRANSFERRED and its content can be very useful not only for the centers of VET but also for organizations in the sector working with the disability community.

Errotu is the leading organization in this intellectual product. All other partners will participate in all tasks. Errotu is a company specialized in working with the elderly and people with dementia and with extensive experience in the development of tasks similar to this in the framework of European projects.

The INNOVATION of this intellectual result goes once again through the previous study that we have carried out. Through this study we have been able to verify that there is no document that collects the characteristics and needs of the group and, therefore, it cannot be transferred to a valid curriculum to be implemented in the field of vocational training.

Please describe the division of work, the tasks leading to the production of the intellectual output and the applied methodology

The methodology that we are going to apply throughout this intellectual result is based on a process of analysis and data collection that will be carried out by each of the countries involved in the project. Before submitting the project application, it was confirmed the need to develop the technical skills of professionals who work with the group of the elderly with ID, being this a key factor in improving their quality of life. The partners have already carried out a preliminary investigation to verify the relevance of the project, but a more extensive data collection is necessary in each of the partner countries, in order to identify the skills that the different professionals who work with elderly with ID in the different residential services and existing day centers need, and offer these professionals the best possible training. The tasks to be carried out are the following:

- 1. Identification of the technical competences that VET teachers who train young people from professional families of Community Service and Social Health Care need to acquire, who in the future can develop their professional career by working with elderly people with ID in each of the partner countries (Greece, Spain, Denmark, United Kingdom)
- 2. Identification of the needs presented at a bio-psycho-social level by elderly people with ID in each of the partner countries of the project (Greece, Spain, Denmark, United Kingdom)
- 3. Preparation of a report for each partner country of approximately 10 pages (in English and the language of the country).
- 4. Summary report of 40 pages (in English) which includes the contributions made by all the partner countries We seek to train the teachers in VET centers who are training future professionals to:
- effectively manage the problems that arise when working with the elderly with ID.

The curriculum that we are going to design is going to become the basis on which the online course that we are going to implement for the VET teachers of the Community Service and Social Health Care families will be based, which is, firstly, our TARGET GROUP. This online training will be the space where all the materials and products produced in the previous intellectual results are reflected and it will respond to the NEEDS detected prior to the start of the project by all the partners in each of their respective countries. This previous detection work has been key to clearly identify the objectives that we were going to promote in the AIDA project. It was necessary to generate a tool where we can respond to these needs, a tool that could reach a significant number of teachers and professionals, our main TARGET GROUP, so that its piloting would be as meaningful as possible. This training will enable a large number of people to be trained in working with the elderly with ID from a completely new and innovative perspective. A perspective where we see the person in an integral way, attending to their bio-psycho-social needs and ultimately seeking to improve quality of life through the active aging program. It is also a complete tool to organize the contents linked to learning, planning the configuration of the contents and also taking into account motivational factors of the target group. All of this will serve as the basis for the development of online training with guidelines that provide an innovative approach to VET. It will have a pedagogy not based on the school curriculum but on experiences and research results. Which have been carried out prior to this intellectual result and are transferable to other interested organizations and entities throughout Europe with the aim to increase the quality, potential, knowledge and skills of the VET teachers of the Community Service and Social Health Care families. The main innovation is not only in the combination of content and innovative pedagogical elements in the framework of care for the elderly with ID, but also in the validation that both Dire Care professionals working with the elderly with ID and relatives make of the materials, curricular content and, ultimately, the online course itself.

To do this, we will develop and follow some guidelines according to a clear and logical structure, with a configuration established from a methodological approach, and learning results that can be TRANSFERRED not only to the teachers and professionals who participate in the piloting but also to their students, in order to ensure that they have complete training in the care of the elderly with ID. This online course will be available in the partner languages with an English version validated linguistically by our British partner. This course will be accessible, open to the public and free from the project website in order to achieve a greater IMPACT in as many entities, organizations and people as possible.



Please describe the division of work, the tasks leading to the production of the intellectual output and the applied methodology

The objective of this online course is double: on one hand, to train the VET teachers of the Professional Families of Community Service and Social Health Care on how to provide comprehensive care to the elderly with ID from a bio-psycho-social perspective. And, on the other hand, we want this training to have an impact on the training of the students of these professional families to whom teachers teach. Previously, the partners have agreed on the curriculum that will define the content of this online course which, in turn, is based on the initial analysis carried out in Intellectual Result 1. It will be the partners who agree on the format of the online course. This draft will include the training plan for each module, along with the designated training hours. This module will also have complementary material in the form of documents, web pages, videos, etc. that will complement each of the modules. P-consulting will supervise each of the steps that we are taking, given the complexity of the development and implementation of this type of online training. That is why we have divided the tasks into three phases:

PHASE 1. DESIGN OF THE ONLINE COURSE. This phase will last approximately 4 months and all the partners will contribute by providing the basic materials of the course to design and develop the learning objects of each module. During this phase, we will establish the methodology to follow, as well as the complementary materials that we will use to illustrate the contents of each module. In addition, during this phase, professionals and family members of the elderly with ID, as well as VET teachers from each of the partner countries, will participate, validating the materials of each module, providing resources, and giving their opinion and points of view on the design. The course will be basically online, maintaining close contact with the participants at all times via the web or email. We will plan two meetings with the participants: an initial one, where we will present online training and resolve doubts, and a final one, where -after completing the online training- we will collect all those suggestions for improvement sent by the teaching staff.

PHASE 2: CREATION OF THE CONTENTS OF THE ONLINE COURSE This phase will last approximately 3 months. The tools used for the creation will be free and open source, such as Moodle, Learn Press, XERTE, WP learning PRO or others similar platforms, provided by P-consulting. The design of the computer system (especially the user interface) plays an important role in the design of online training. Learning activities in technology-based environments play a critical role in determining learning outcomes; they determine students engagement with course materials and the forms of knowledge construction that will take place. There will be two key factors in this phase: technological and digital issues, inherent to the design of the training, and the methodological and content aspects that ensure not only the quality of the training but also that it is an intuitive and easily accessible tool.

PHASE 3: PREVIOUS PILOTING OF THE TOOL This phase will last approximately 1 to 2 months. During this session, all partners will participate in small pilot tests of online training to ensure proper operation once the pilot of the training begins with the VET teachers who will receive the training. The course will contain an access guide to the training, simple and functional. This guide will be translated into all the project languages: GR, EN, DK and SP.

This online training will be the basis for providing training to the VET teachers of the Community Service and Social Health Care families of each of the partner countries involved in the project, thus covering their training NEEDS. It will include all the theoretical backgrounds investigated in Intellectual Result 1 and developed in Intellectual Result 2 and, above all, it will provide concrete competencies for teachers, which will be our TARGET GROUP. It will be a complete online training to train VET staff from an effective and quality perspective through an INNOVATIVE approach in the care and treatment of elderly people with ID. One of the main innovations that we will develop in this Intellectual Result is to carry out a prior testing of the tool by Direct Care professionals working with the elderly with ID and relatives (External evaluation team) in each of the countries to try to guarantee the suitability of the tool. The basis on which this online training will be implemented will be:

- a) An innovative methodological structure with a complementary clarifying material that will contain videos, good practical examples, etc.
- b) Prior testing of the tool by our external evaluation team.
- c) Optimal duration of each of the modules (5 modules of 10 hours each).
- d) Translated into all the languages of the project to facilitate access to the training of the participants, regardless of their level of English.
- e) Constant support from the project partners for the resolution of doubts, gueries and suggestions.
- f) 2 face-to-face meetings: one at the beginning and one at the end of the training. The first meeting will be to present the course to the teachers and explain how the tool works and the final meeting will allow us to collect and apply the contributions and improvements of the teachers.





The entire study plan will be validated through a certificate of achievement issued by Centro San Viator and which will accredit the training to all those participants who complete the training in full. We expect the expected IMPACT of the training to be high -with at least the participation of 15 VET teachers per country- although our expectations are that this number will increase with the participation of professionals from the sector interested in improving their professional training. This will be a valuable instrument for improvement that each member will transfer to a report of no more than 5 pages in which they will collect the most significant aspects of the implementation phase of the online course. Likewise, the potential for TRANSFERABILITY of this Intellectual Result will become clear when, on the one hand, the teachers involved in the training can apply this knowledge acquired reach their students and, the professionals involved in the training can apply this knowledge and their daily work in the care of the elderly with ID. It will include all the theoretical background investigated in Intellectual Result 1 and developed in the Intellectual Result 2 and reflected in the online course (Intellectual Result 3) providing specific competencies for teachers. It will be a complete online training to train VET staff from an effective and quality perspective through an innovative approach in the care and treatment of elderly people with ID. The basis on which this online training will be implemented will be:

- a) An innovative methodological structure with complementary clarifying material that will contain videos, good practical examples, etc.
- b) A prior testing of the tool by professionals and relatives of the elderly with ID in each of the countries to try to guarantee the adequacy of the tool.
- c) Optimum duration of each of the modules (5 modules of 10 hours each).
- d) Translated into all the languages of the project to facilitate access to the training of the participants, regardless of their level of English.
- e) Constant support from the project partners for the resolution of doubts, queries and suggestions.
- f) 2 face-to-face meetings, one at the beginning and one at the end of the training, to present the course to teachers and explain how the tool works, and a final meeting that allows us to collect contributions and improvements from teachers so that they can be applied.

- 2. We will carry out an initial meeting in each of the partner countries (SP, DK, GR, UK) where we will present not only the online course to the selected teachers but also the project in which it is framed so that they have a contextualized idea of it. At this same moment we will collect the necessary data to proceed to register them on the platform.
- 3. During the months of this piloting of the online course with the VET teachers, we will carry out a follow-up in each of the partner countries (SP, DK, GR, UK) (attendance, number of participants, time invested in the realization of each of the modules, connection frequency ...) through the tools developed by Pconsulting for this purpose. In addition, we will offer teachers the possibility of making all the queries or suggestions they wish through the project website or by email to the partner in the country.
- 4. Approach to the Reality of the Elderly with Intellectual Disabilities: current characteristics and necessities

Activity Description (including profile of participants per organisation, goals and results of the activity)

The main objective of this training is to carry out an approach that allows us to approach in a clarifying way the current reality experienced by elderly people with ID and the professionals who work with them on a day-to-day basis. With this training we want to help all partners to understand as accurately as possible what the training in technical skills that we are going to do consists of, so that it is as close as possible to the real needs of the people and facilitates the creation of the content which will make up the online course. The final objective we pursue is to know the reality, the daily work and the difficulties that direct care professionals face when they try to respond to the bio-psychosocial needs of the elderly with ID. For this purpose, the designed content will consist of:

- 1) A presentation of good practices identified in each of the partner countries, both in terms of direct care for the elderly with ID and the complementary training of professionals working with them.
- 2) Presentation of the support measures that professionals have in the exercise of their profession.
- 3) How to design a curriculum for VET teachers: methodology and curricular sequencing.
- 6) How to implement the curriculum in VET centers.
- 7) How to obtain the maximum benefit from e-learning training: advantages, difficulties and how to solve them
- 7) Visits to care centers for the elderly with ID (residences, day centers, health care units, psychosocial support centers ...).
- 8) General visit to Centro San Viator with emphasis on Community Service CFGS.

## **Background Information**

What is the added value of these Learning, Teaching or Training activities (including long-term activities) with regards to the achievement of the project objectives?

The success of this project requires to a large extent that all partners understand the technical issues of the professionals who work with the elderly with ID, as well as the specific needs and characteristics of the group. VET teachers need to receive specific training that enables them to train future workers who will adequately respond to the needs of the elderly with ID. It is also important to take into account the design of the curriculum and the learning style of VET teachers as well as their teaching style. This will be achieved by working with a multiprofessional team like the one that makes up this project. The learning, teaching and training activities organized within the AIDA project are of crucial importance to achieve the objectives that we have set ourselves in this project. These activities may also be transferred as good practices not only between the partner countries and the institutions involved in the project but also between other entities and organizations. This is one of the main objectives that we propose and will, therefore, promote the European dimension of the project.

During this training, participants will have the opportunity to work in depth on curricular models, digital tools for online training and good practice approaches in direct care for the elderly with ID. During this training, participants will:

- Receive good practice training, together with a detailed presentation of individual good practices selected by country.
- Discuss how a curriculum can be developed as closely as possible to the objectives of the project.
- Acquire more knowledge about online training.
- Analyze the possibilities of knowledge transfer. As all the participants are professionals from sectors related to AIDA, we want to carry out intense work in which all the participants can share new methodologies and approaches from a didactic point of view. The transferability of the training will be carried out through the socialization of the knowledge acquired by each of the participants in their own centers and organizations, in other related entities and even through planned multiplier events.

Regarding the professional profile of the participants, we will select those who, within each entity, can make the most of the training. For this purpose we will look for profilesthat have contracted experience in working with people with disabilities, the elderly, mental illness or psychosanitary assistance. The participation of digital experts in the design of the online training and pedagogues with experience in the design of curricular material will also be interesting. Centro San Viator will participate in the joint training of staff, with professionals who work with people with ID, and their experience and good practices will be valuable to the other participants of the project partners. In addition, San Viator will contact professionals who are experts in the care of the elderly with ID from different entities with whom the centre works on a regular basis and who can contribute a vision of great value to the project. Participants will learn from experts in the design of specific learning resources for VET teachers who train students from professional families of Community Service and Social Health Care. This will be key in the curriculum design phase and the creation of the online course. Throughout the training, we will try to generate moments of co-creation in which the participants will jointly agree and complete the curriculum for the elearning course. We will seek to reach agreements regarding the main structure, the learning materials and the learning results of the courses, always allowing ourselves to be advised by p-consulting, professionals with extensive





experience in the design, creation and implementation of on-line training. It should be noted that the event organizer (Centro San Viator) has a lot of experience in organizing training, offering adequate facilities, infrastructure and equipment.

What is the expected impact on the participants, participating organisations, target groups and other relevant stakeholders?

With this project we hope to have a significant impact on the professionals and organizations involved in each and every one of the scheduled activities. We also hope that the impact on the teachers who participate in the pedagogical training will be noticeable, helping them in the planning and implementation of specific educational programs, so that they can subsequently train their students on key issues of care and promotion of the elderly with ID through the implementation of active aging programs.

On the one hand, the VET centers will have a specific online training course on active aging of people with ID available to be used in training VET teachers of the Community Service and Social Health Care families. As a result, teachers will gain additional knowledge and experience on how to train their students on this topic, thus improving their employability. This will also help students to feel more self-confident and more prepared to take initiatives in direct care for the elderly with ID, taking care of their physical and emotional state. With all this, we will also improve the competences of future workers, increase their motivation and satisfaction at work. And finally, increase the quality of life of the elderly with ID. In a more global dimension, we can say that this project is aligned with Europe's priorities regarding priority issues such as social inclusion, non-discrimination against this group and an exercise of active citizenship, making people with ID able to be protagonists of their own life.

The third sector organizations and social entities participating in the project will be more aware of the existing great need to develop specific plans to care for this group in a comprehensive manner, taking into account all the areas that make up the person. This project will show and provide other stakeholders, such as Social Services or Health Care, the potential benefit of training professionals in specific aspects related to the active aging of the elderly with ID. More importantly, this could be a tool to start an even longer process, taking into account the growing increase in the number of older people in Europe, a process that will ultimately have a great impact on the quality of life of many older adults with ID and, in the last case, also in public budgets.

Public policy makers will be able to draw important conclusions and ideas on this topic, training professionals who work with ID elderly people, thus helping them more effectively in their daily lives.

If we manage to improve the quality of life of this group, this will mean:

- saving or optimization in public budgets or a better investment
- Care of the person with a smaller number of external supports





What is the desired impact of the project at the local, regional, national, European and/or international levels?

We want this project to have an impact on different levels:

- Provide a new type of courses to teachers of VET centers of the Community Service and Social Health Care families, so that future students can work in centers that serve the group of the elderly with DI, as well as to other professionals in the sector.
- -Have a greater understanding and responsiveness to care for the elderly with ID.
- Promote a more active participation in society in the field of intellectual disability.
- Promote a more positive attitude towards values such as inclusion and the elimination of social inequality.
- Promote social inclusion and non-discrimination.
- Raise awareness in society in general about the aging of people with intellectual disabilities, their specific needs and the care they need to improve their quality of life. At all times we will ensure that the work networks established in each country contribute to creating cooperation between all of them. Cooperation that benefits all participants from the knowledge that others can contribute on the subject and that has a direct impact on the target groups locally, regionally and nationally in each country. At the European level, EfVET member partners (SOSU Oestjylland former name: SOSU Aarhus, p-consulting, and Centro San Viator) can ensure wide dissemination of the project through EfVET (a professional association at European level that has was created by and for VET centers and companies related to them in all European countries www.efvet.org), thus increasing the impact throughout Europe through its 1,500 members of VET institutions, conferences, links with networks of the EU and participation in EC consultations with the sector. This group needs to be attended as soon as possible, given that their life expectancy, as studies show, is increasing and the direct care services for the group still do not have professionals specifically trained in active aging for the elderly with ID, who present specific health, emotional and social needs different from of the rest of the elderly.

Each partner will establish their target group within their country and will develop a database of all those who may be interested. They will regularly monitor the progress of the objectives of the dissemination and exploitation plan and the adopted impact measures. All VET centers participating in the project have extensive experience in the implementation of dissemination strategies in European projects and will work and support national partners and networks to communicate the results and products as they are being achieved

In addition, multiplier events will be organized in the UK, Denmark, Greece and Spain, resulting in another good basis for dissemination. As a result, we hope to open new contacts and channels. All the achieved results will be available on the project website. There will also be a link to the website of the project in all the web pages of the partners so that anyone can visit it for further information. At the same time, we will use the dissemination platform that ERASMUS + offers and the different national agencies.

Thus, apart from the associated organizations and those who collaborate peripherally with the project, the target audience will include:

- Third sector organizations who work with the group of people with ID
- -Public and private entities whose target group is the elderly with ID
- -Associations who work with people with ID
- Networks of entities who work with people with ID
- Social networks
- Non-governmental organizations who collaborate with people with intellectual disabilities
- VET centers that train students in the Community Service or Social Health Care families





Which activities will you and your partner carry out in order to share the results of your project beyond your partnership?

The dissemination and exploration of the outcomes is very important and an integral part of the project throughout its life: from the beginning of the project, during its implementation and after its completion. At the beginning of the project, a calendar of activities will be set with all the project partners.

Moreover, other communication actions such as articles, brochures, project webpage, online forum, online dissemination through the webpages of the project organizations, newsletters, etc. We also plan that project partners take part in seminars, workshops, conferences, etc on issues related to the project.

More specifically, we can detail the following specific communication actions:

- Three newsletters will be published throughout the whole project. Each partner will create a list of possible contacts to whom the newsletters will be sent in each country.
- Different project dissemination events will be organized:

Seminars, conferences and workshops where the information about project AIDA will be offered to all the participants in each project partner country.

Local, regional and national forums. We will also offer information about the project to any interested parties through conferences and meetings between teachers or professionals working with this group of people.

Multiplier events. All multiplier events will facilitate the dissemination of the results obtained throughout the project. Each event will be actively planned and it will register participants.

Public events. The dissemination will also be attempted in public events in which partner countries take part


Press release. All the information about the AIDA project will be published through the media of the different partner countries to which we have access.


- -Photographs Videos. Photographs and videos related to the project (meetings, training, events, etc.) will be uploaded to the project webpage, to each partners webpage and other websites.
- Project partners also have their own websites. These will be used (as part of the dissemination strategy) to contact and carry out the corresponding updates.
- -P-consulting, SOSU Oestjylland and Centro San Viator are members of EfVET, professional european association created by and for the collaboration of VET centres and other peripheral companies and entities, which is present in most european countries. The EfVET newsletter will also be used. This action and the consequent updates will be carried out quarterly. Thus, approximately 1500 organizations across Europe will be updated periodically. The contact of each partner will be included in the newsletter so that any interested party in the country can contact them directly for further information.

Interested parties will be given voice, and helped to write articles, create their own blogs, etc. so that the dissemination of the project is as appropriate as possible to the idiosyncrasy of each country.

Who will be responsible for the dissemination activities within your partnership and which specific expertise do they have in this area? What resources will you make available to allow for the proper implementation of your dissemination plans?

Although the dissemination and exploitation of the results will be a common task for all partners throughout the useful life of the project, Centro San Viator, in collaboration with Errotu, will be the leader of these activities and responsible for monitoring the dissemination activities carried out by the partners. Centro San Viator has a rich







experience in project management, both as a partner and as coordinator, in different programs with European funding and has carried out coordination tasks in other European projects, such as EUMOB, which received an excellent evaluation from SEPIE in the presentation of its final report.

San Viator Center will carry out the following main tasks:

- Prepare a strategy for the dissemination and exploitation of results in collaboration with all partners and with the support of Errotu. This strategy will be part of a dissemination manual which will include an action plan, models for the realization of the different reports and plans at the national level for each of the partners, based on their characteristics and ability to share knowledge, and the different dissemination channels that will be used.
- Collaborate with all partners for the development of the main dissemination tools of the project: website, different brochures that will be translated into all the languages of partner countries, with a total of 100 brochures per partner, taking into account that in Spain there are 2 partners, Centro San Viator and Errotu (total 500 brochures);
- Preparation of 4 newsletters with specific information on the development of the project and its phases.
- Coordination in the writing and dissemination of at least 1 article to be published in each country.
- Carry out monitoring of all the dissemination activities of all partners every 6 months approximately.
- Monitoring of all dissemination events in all partner countries.
- Collaborate closely with other collaborating entities of the project to guarantee wide dissemination at European level.
- Carry out a record of all the dissemination activities that are carried out in each country as part of the general documentation of the project.
- Inform public entities, administrations and networks at the local, regional, national and European level.
- Organize a local multiplier event per country.
- Organize a Final Conference in which the results, resources and materials generated in the AIDA project will be presented to the largest number of entities, VET centers and third sector organizations possible.
- Present the AIDA project at the EfVET Annual Conference in which around 300 VET professionals from all over Europe participate every year, as well as in other forums and events

Along with this, all partners will implement dissemination activities at the local, regional, national and European level, for which they will designate one person per organization with experience in similar tasks.

### Sustainability

What are the activities and results that will be maintained after the end of the EU funding, and how will you ensure the resources needed to sustain them?

During the preparation of the project, each partner outlined the sustainability strategies that will be carried out at the end of the project life. This project was born out of a need which each partner has verified in each and every one of the participating countries, so the design of a long-term action plan for the progressive deployment of all of them once the project has finished is something that is present in each of the project partners.

We want to produce high-quality outcomes to generate training content which can be implemented in VET centres in all partner countries so that it not only allows teachers to get a greater technical training but it can also be included in the curriculum of the VET students of the aforementioned professional families as complementary training. This is our ultimate goal: to train better professionals who contribute to improving the quality of life of the elderly with ID.

In fact, when it comes to sustainability, the results of the various intellectual outcomes are already structured in a way which ensures the sustainability of the project upon completion

The partners of the project will carry out the following actions to guarantee the sustainability of the project AIDA:

- 1. Outcomes and teaching products: each partner will use the results of the project during the curriculum implementation and the piloting of the online course in the different VET centres along with the other participating organizations.
- Centro San Viator will focus on the creation of a coherent sustainability plan to be implemented, as soon as the project finishes and the teaching modules have been piloted and evaluated with the ultimate teaching material in all the related VET centres, public and private entities and organizations. All of them will be able to use this material completely and free of charge. We want to reach the largest number of education centres, third sector entities and organizations so as to contribute to improving the comprehensive care of the elderly with ID, their families and those professionals who work with them on a daily basis.
- 2. Partners such as SoSU, P-Consulting, Errotu, BTC and, doubtlessly, Centro San Viator have stated their availability to evaluate the project outcomes and give feedback on the designed training. When the online course has the highest quality content, it will be promoted and disseminated within the local and regional VET centres, as well as among the networks of companies and organizations that work with the elderly with ID, thus creating an important impact both regionally and nationally.
- 3. All the products created by P-consulting will be completely available and free of charge as open educational resource. The e-learning platform facilitates the access for all, also in the distance. P-consulting commits to keep the designed platforms running for at least 2 years after the ending of the project.
- 4. Transferability: the project products will be designed, implemented, tested and assessed by partners from 4 different countries and, for this reason, the outcomes of the project can be used by all. The fact that different types of organizations operating in 4 different countries will test and adjust this model makes us think that it could also be implemented in other EU and Non-EU contexts.
- 5. Private funding: partners have all a regional and national network of entities, both public and private, who fund social projects in each of their countries.
